<u>PURPOSE</u>: The purpose of this bill is to appropriate State general funds for the State Commission on Fatherhood.

<u>DEPARTMENT'S POSITION:</u> The Department of Human Services (DHS) appreciates the intent of this bill and respectfully requests that its passage does not replace nor adversely impact the priorities in the Executive Biennium Budget. The Department recognizes the important role that fathers play in the family and in the lives of their children.

The Hawaii Commission on Fatherhood was established by Act 156, SLH 2003, and directs the Commission to serve in an advisory capacity to State agencies to promote healthy family relationships between parents and children. The Commission is authorized to make recommendations on programs, services, and contracts relating to children and families.

Across the nation, there is a renewed understanding of the unique importance of fathers in the lives of their children, families, and communities. It is widely recognized that children are more likely to thrive with support, guidance, and nurturing from both parents. The presence of fathers has a positive impact on the lives of their children, as reflected in better school performance, fewer high-risk behaviors, higher self-esteem, and less substance abuse. Healthy families mean less impact on our child protective services and at-risk youth and youth offender programs and the Judiciary. However, many young men today are themselves fatherless, lack appropriate role models, and are in need of information and education regarding the appropriate roles and responsibilities of fathers.

The Commission on Fatherhood plays an important role in promoting healthy family relationships between parents and children and promotes involved, nurturing, and responsible fatherhood.

Chair Senator Chun Oakland and Members of the Human Services Committee, thank you for introducing and hearing SB 800.

The State Commission on Fatherhood strongly supports SB 800, with the following suggested amendments:

1—We request AMENDING the fiscal year designation in SECTION 2 of SB 800 from FY 2009-10 to FY 2009-11 and designating an appropriation of \$150,000 for each fiscal year to fund the implementation of the State Commission on Fatherhood's strategic plan by providing travel expenses of Neighbor Island Commissioners, establishing an office, and hiring a Director and a clerical staff person. The goals and objectives of the Fatherhood Commission's strategic plan are spelled out in SB 800.

2—We also request adding language to SB 800 that would AMEND the voting member terms of section of the Hawaii Revised Statutes (§577E-3 (3)(c)?) that establishes the State Commission on Fatherhood to be <u>four (4) year term appointments</u> with a limit of two (2) terms for voting members.

Participation in the monthly Fatherhood Commission meetings by voting Commission members has been severely inhibited by the present two (2) year terms as well as by difficulties with making timely voting Commission members replacement appointments when vacancies occur.

The State Commission on Fatherhood members support passage of SB 800, with the above suggested amendments.
