<u>PURPOSE:</u> The purpose of this bill is to repeal section 348-9, Hawaii

Revised Statutes (HRS), which establishes the Statewide Council on Independent

Living in the Department of Human Services.

<u>DEPARTMENT'S POSITION</u>: The Department of Human Services (DHS) strongly supports this Administration-sponsored bill. For the State to be eligible to receive Federal financial assistance, the Federal Rehabilitation Act, title 29 United States Code, section 796d, requires the State to establish a Statewide Independent Living Council, which cannot be established as an entity within a state agency.

Section 348-9, HRS, establishes a Statewide Council on Independent Living in DHS. Section 348-9, Hawaii Revised Statutes, was well-intended, but is unnecessary and has resulted in confusion. Section 348-9 is unnecessary because

the Statewide Independent Living Council can be established through the State's

Title VII State Plan that each state is required to have to receive Federal funds under

Title VII of the Federal Rehabilitation Act. The State currently receives more than

\$296,000 in Federal funds for independent living services.

Repealing section 348-9 and relying instead on the State's Title VII State Plan to establish a Statewide Independent Living Council, will satisfy the State's Title VII requirement.

If this bill is not passed, public confusion will continue.

The State Council on Developmental Disabilities **SUPPORTS SB 921 SD2**. The purpose of this bill is to repeal Section 348-9, Hawaii Revised Statutes (HRS), that establishes the Statewide Council on Independent Living.

The Statewide Council on Independent Living was established by Act 197, Session Laws of Hawaii 1993, and placed within DHS. Federal law (Title 29 United States Code Section 796D) requires states to establish statewide councils on independent living. However, councils cannot be established as an entity within a state agency in order to be eligible to receive Federal financial assistance. Repealing Section 348-9, HRS, would abolish the Statewide Council on Independent Living within DHS, comply with Federal law, and allow the Council to be eligible to receive Federal funds.

Supporting SB 921, SD2, Relating to Federal Financial Assistance for Independent Living Services and Centers

Hawaii Centers for Independent Living is a non-profit organization operated by and for people with disabilities to ensure their rights to live independently and fully integrated in the community of their choice, outside of institutional care settings. As a non-profit, statewide resource, HCIL serves people of any age with any type of disability. HCIL was founded on the historical constitutional beliefs of civil rights and the empowerment of people with disabilities to have equal access, opportunities, and choices in life, no matter how severe their disability.

We support SB921, SD2, Relating to Federal Financial Assistance for Independent Living Services and Centers.

As the only Center for Independent Living in the state of Hawai'i, HCIL works closely with the Statewide Independent Living Council (SILC) and operates under the State Plan for Independent Living (SPIL) established by the SILC. HCIL's executive director is a mandated member of SILC under 34 CFR 364.21(b)(2)(i)(A), since there is only one center, and thus one center director, in the state.

H.R.S. 348-9 establishes the "State Independent Living Council" within the Department of Human Services. This contravenes 34 CFR 364.21(a)(2), which states that statewide independent living councils are not to be included within any state agency, including the designated state unit (DSU). The Statewide Independent Living Council is a 501(c)3 nonprofit organization, not part of any state agency, although its members are appointed by the Governor in accordance with 34 CFR 364.21(b)(1).

We believe that passage of SB921, SD2, repealing H.R.S. 348-9, will resolve the persistent confusion about the status of the SILC relevant to state government and will help to bring the SILC into compliance with applicable Federal regulations.

We urge the committee to pass SB921, SD2. Thank you for this opportunity to testify.
