Chair Taniguchi and members of the Judiciary & Government Operations Committee:

Thank you for this opportunity to testify in support of SB 98.

In the current climate of economic austerity and fiscal uncertainty, municipalities across the country are seeking an array of tools to help them weather this storm. The counties of Hawaii are no different. One tool that could be of tremendous value in reducing costs is our memberships in the National Association of Counties (NACo) through cooperative contracts.

If, for example, a large NACo member municipality elsewhere uses its purchasing power to obtain goods at low price that is made available through a cooperative contract, county governments in Hawaii cannot take advantage of that option without an amendment to Chapter 103D-802, Hawaii Revised Statutes, as proposed in this measure.

The Hawaii State Association of Counties believes that local governments are in the best position to assess their individual needs and the needs of their constituents. This option would provide local governments with another tool to help reduce costs and save taxpayer dollars while still purchasing necessary goods and services.

We firmly believe that local governments are fully capable of making competent, ethical decisions on whether and when to use a cooperative contract on behalf of its citizens.

Mahalo for this opportunity to testify, and I look forward to further discussions.
