# TESTIMONY OF THE DEPARTMENT OF TRANSPORTATION SENATE CONCURRENT RESOLUTION NO. 119 COMMITTEE ON TRANSPORTATION

Senate Concurrent Resolution 119 recognizes the importance of bicycling, encourages Hawaii residents to ride bicycles for transportation as well as recreation, and urges the Hawaii Department of Transportation to embrace "complete streets" policies.

The Department supports the intent of these resolutions. The DOT and the Federal Highway Administration to plan and design state highways to safely accommodate pedestrians, bicyclists, and public bus stops except on interstate freeways where such activities are prohibited. A "complete streets" approach is already being incorporated into our land transportation planning program updates that include significant stakeholder involvement.
