Madam Chair and members of the Senate Ways and Means Committee, I am Debbie Shimizu, Executive Director of the National Association of Social Workers (NASW), Hawaii Chapter. NASW is the largest professional organization for social workers in Hawaii .We are testifying in SUPPORT of SCR 170 SD1 and request that social workers be included in any strategic and comprehensive plan for health care in Hawaii.

Social workers are important components of the health care system. We provide services to individuals and their families navigating complex system of services. From health clinics to schools, hospitals to public welfare agencies, elder care agencies to child welfare agencies, social workers are often responsible for coordinating a range of care services for their clients. These services can include housing referrals, income maintenance, protective and preventive services, and health care services. We are a discipline that connects people to services and other important community resources. Social workers are the "key" that opens doors of access to many services.

Social work professionals are also a crucial force in addressing and eliminating health care disparities, not only because of their experience in health care environments, but also because of their commitment to clients who are likely to face such disparities in a variety of settings. We hope that the health care summit will also address disparities in health care.

In 2004, NASW (national) established a Center for Workforce Studies to conduct studies of the current social work labor force as well as collect information from other sources in order to serve as a unique clearinghouse for educators, policy makers, social workers, and public and private work force planners. A study was conducted of licensed social workers in health care settings and it concluded that the "aging-out" of the frontline social worker providing direct services to clients in a wide range of community agencies was a serious concern. Social work will experience a "double squeeze" as a result of the Baby Boomer phenomenon. There will be an explosion in the demand for health and social services provided by social workers as an estimated 70 million people will be over age 65 by 2030. At the same time, a substantial cohort of frontline social workers will be leaving the workforce. According to data projections of the Bureau of Labor Statistics, social work is one of the occupations most affected by Baby Boomer retirements, Occupations dominated by women, like social work, are especially vulnerable with an aging workforce because women's level of workforce participation is lower than men's as they approach retirement age (Toossi, 2005). Additional studies about how the growing demand for health care services will affect the role and numbers of social workers needed in key settings will be useful to assure that adequate number of health care social workers are recruited and supported in this field.

We hope you will include social workers as part of the health care summit. Thank you for this opportunity to testify.

Chair Kim and Vice Chair Tsutsui, and members of the Committee on Way and Means. My name is George Massengale and on behalf of the American Cancer Society Hawaii Pacific Inc., we are offering this testimony in strong support of SCR170.

The American Cancer Society Hawaii Pacific Inc. was formed in 1959, and is a community-based, voluntary health organization dedicated to eliminating cancer as a major health problem by preventing cancer, saving lives, and diminishing suffering from cancer, through research, education, advocacy, and service. This also includes advocating for public health policies that improve our access to health care.

Two years ago the American Cancer Society launched a Health Access Campaign to foster debate on how to fix problems with our current health care structure. We believe that convening a Hawaii Health Care Summit is the first step in addressing the complexities of health care reform.

Although the Society does not endorse any particular plan for healthcare reform, we do believe that the health care summit focus on four key principles in defining health care in Hawaii:

- Adequate: People must have timely access to the full range of health care, including prevention and early detection.
- Affordable: Health care cost should be based on the patient's ability to pay.
- Available: Our residents need to have coverage no matter what their health status is or what treatments they've had in the past.
- Administratively simple: The health care process should be easy to understand and navigate.

We truly believe that if a concerted effort were undertaken to develop a comprehensive health care plan in Hawaii we would be able to provide quality health care to all our residents regardless of insurance status, or current medical condition and need.

The Hawaii Government Employees Association supports the purpose and intent of S.C.R. 170, S.D. 1. While there are many positive aspects of health care in Hawaii thanks to the state's prepaid health care act, there are also a number of serious problems noted in S.C.R. 170, S.D. 1. Everyone benefits from healthy communities, where we all have access to affordable, quality health care from a provider of our choice, when we need it, at a cost we can afford. The goal of the HGEA and our national union AFSCME is affordable, quality health care for everyone.

One of the issues of great concern to the HGEA is the continued escalation of health care for our members and the public at large. Over the next two years, public employees are facing significant increases in their health care premiums and co-payments along with possible reductions in the scope of coverage. Our current health care system locally and nationally is no longer affordable for many families, businesses and government. We need a comprehensive solution to secure our families' health and a healthy economy. The ever increasing cost of health care is not sustainable either.

The long-term goal should be to provide health care coverage with out-of-pocket costs, including premiums and co-payments that are based on a family's ability to pay for health care and without limits on payments for covered services. We respectfully suggest several amendments to strengthen S.C.R. 170, S.D. 1. First, consumers should be among the twenty-five members of the health care summit. Second, the summit's strategic and comprehensive plan should address the cost of health care and steps to make it more affordable and accessible.
