A BILL FOR AN ACT

RELATING TO MOTOR VEHICLE EXPRESS WARRANTY ENFORCEMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1 | SECTION 1. Section 4811-2, Hawaii Revised Statutes, is |

| 5 | (1) Means a self-propelled vehicle primarily designed for |
| 6 | the transportation of persons or property over public |

| 8 | personal, family, or household purposes; |
| 9 | (2) Includes [but shall not be limited to]: |
| 10 | (A) A motorcycle as defined in section 286-2, but |
| 11 | excluding a motor scooter; |
| 12 | $[\frac{A}{A}]$ (B) A "demonstrator", which means a vehicle |
| 13 | assigned by a dealer for the purpose of |
| 14 | demonstrating qualities and characteristics |
| 15 | common to vehicles of the same or similar model |
| 16 | or type; |

| 1 | [(B)] (C) An individually registered vehicle used for |
|----|---|
| 2 | an individual's business purposes as well as for |
| 3 | personal, family, or household purposes; and |
| 4 | [(C)] <u>(D)</u> A vehicle owned or leased by a sole |
| 5 | proprietorship, corporation, or partnership which |
| 6 | has purchased or leased no more than one vehicle |
| 7 | per year, used for household, individual, or |
| 8 | personal use in addition to business use; |

| 10 | (3) Shall not include mopeds[, motoreyeles,] or motor |
| 11 | scooters, as those terms are defined in chapter 286, |
| 12 | or vehicles over [10,000] ten thousand pounds, gross |
| 13 | vehicle weight rating." |
| 14 | SECTION 2. Statutory material to be repealed is bracketed |
| 15 | and stricken. New statutory material is underscored. |
| 16 | SECTION 3. This Act shall take effect upon its approval; |
| 17 | provided that section 1 of this Act shall apply to sales of |
| 18 | motorcycles that take place on or after September 1, 2010. |
