A BILL FOR AN ACT

RELATING TO GOVERNMENT SHARED SERVICES TECHNOLOGY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to establish the 2 shared services technology special fund, which will permit the 3 State of Hawaii to benefit from substantial cost savings when 4 implementing a statewide, centrally coordinated planning and 5 implementation process for common information technology 6 systems, hardware, and software across its many departments and 7 agencies.

8 Participating state departments and agencies shall 9 contribute to this fund so targeted acquisitions may employ 10 "bulk purchases" and coordinated multi-department and statewide 11 contracts and agreements to generate overall cost reductions 12 from the resulting economies of scale and decreased 13 administrative paperwork and processing time.

14 The department of accounting and general services, 15 information and communication services division, shall expend 16 these funds for the purpose of managing and administering shared 17 services that may include, but are not limited to, information



7	SECTION 2. Chapter 36, Hawaii Revised Statutes, is amended

A BILL FOR AN ACT RELATING TO GOVERNMENT SHARED SERVICES TECHNOLOGY.

PURPOSE: To provide a funding mechanism to support a State of Hawaii agreement for technology shared to be managed and administered as a centralized service on behalf of state agencies and departments.

MEANS:

Add a new section to chapter 36, Hawaii Revised Statutes (HRS).

This bill establishes a central fund that JUSTIFICATION: all departments can contribute to such that no one agency shoulders the entire cost burden for the technology solution. Areas where this type of shared services technology can be applied include online training, memberships, off-site storage, telecommunications, virtual servers, database licenses and hardened facilities. We have observed some success in the past with memberships, legislative tracking, financial data mart and of course our telecommunications network, which is the foundational element for shared services. Consolidating technology solutions and functions shared by multiple agencies will free agencies to focus on their core missions of providing essential services. Many states and private sector entities are pursuing similar tactics. Volume discounts and a reduction in administrative paperwork can result.

Impact on the public: A consolidation of technology solutions will result in reduced costs to the State of Hawaii, which benefits everyone.



Impact on the department and other agencies: The ability to take part in a Shared Services Technology Special Fund can relieve the participating department or agency of the burden of contracting, paying, configuring, connecting and installing separately. Furthermore the quality and price point for the technology is likely to be more favorable than that achieved by any one department on its own.

Areas where shared services technology could be applied effectively:

Geographical Information Systems (GIS). The ability to share the wealth of information captured in State mapping efforts could be enabled for all. Providing the ability for any department to access maps and not just the handful of departments that can afford the storage, software, hardware and licenses to do so. Multiple instances of GIS systems could be consolidated into a Statewide system with the maps made available to the Web for things like mash ups (similar to Google) to specific locations of incidents or projects.

Software Licenses. Currently some vendors have several different contracts with the State of Hawaii for the same products. By bundling some of those purchases we can meet our needs more cost effectively without diminishing the quality of the products or services obtained.

Financial Planning Systems. Virtually every department has its own Financial Management system to handle their budgets, accounts and purchase orders. These systems range from simple spreadsheets, to complex commercial off the shelf systems or custom written programs.

Personnel Planning Systems. Much like Financial Planning systems, there exist a wide variety of methods for personnel planning. Managing leave, time recording etc. Many of the processes are handled manually with paper forms being routed amongst departments. This is a back office process ripe for automation but no single agency can address it, and therefore fund it, on its own.

Disaster Recovery. In the absence of a Statewide Disaster Recovery solution, departments use their own available funds to put towards efforts that would serve only their needs. By diverting these one-off Disaster Recovery (DR) implementations into a Shared DR Implementation that can grow over time, we can incrementally develop the ability to meet State of Hawaii needed DR goals.

- Incurring networking connectivity charges once, then increasing shared bandwidth as needed.
- Economies of scale. On its own, a department may need to rent a cabinet as the minimum quantity allowed by the vendor, but really only need part of it. With a statewide contract, that other part can be shared with other agencies on a prorated basis as a managed service.
