RELATING TO THE PENAL CODE.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 2. Section 707-700, Hawaii Revised Statutes, is
3	amended by adding a new definition to be appropriately inserted
4	and to read as follows:
5	""Simulated firearm" means any object that:
6	(1) Substantially resembles a firearm;
7	(2) Can reasonably be perceived to be a firearm; or
8	(3) Is used or brandished as a firearm."
9	SECTION 3. Section 707-716, Hawaii Revised Statutes, is
10	amended by amending subsection (1) to read as follows:
11	"(1) A person commits the offense of terroristic
12	threatening in the first degree if the person commits
13	terroristic threatening:
14	(a) By threatening another person on more than one
15	occasion for the same or a similar purpose;
16	(b) By threats made in a common scheme against different
17	persons;
18	(c) Against a public servant arising out of the
19	performance of the public servant's official duties.
20	For the purposes of this paragraph, "public servant"
21	includes but is not limited to an educational worker.

1		"Educational worker" has the same meaning as defined
2		in section 707-711;
3	(D)	Against any emergency medical services personnel who
4		is engaged in the performance of duty. For purposes
5		of this paragraph, "emergency medical services
6		personnel" shall have the same meaning as in section
7		321-222; or
8	(e)	With the use of a dangerous instrument or a simulated

Includes in the offense of murder in the second degree acts committed with the intent to cause serious bodily injury to another person, which result in the death of that person. Defines "simulated firearm" and makes the use of a simulated firearm during a robbery a robbery in the first degree and while committing an act of terroristic threatening a terroristic threatening in the first degree. Effective December 21, 2058. (HB1019 HD1)
