A BILL FOR AN ACT

MAKING AN EMERGENCY APPROPRIATION FOR THE DEPARTMENT OF HUMAN SERVICES TO ADDRESS THE BUDGET SHORTFALL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. This Act is recommended by the governor for
 immediate passage in accordance with section 9 of article VII of
 the Constitution of the State of Hawaii.

SECTION 2. A critical fiscal emergency exists. Many 4 unprecedented events have converged to create an economic, 5 financial, and fiscal environment that threatens the very 6 foundation of our national economy. Problems that arose in the 7 national housing sector and sub-prime mortgage market last year 8 have radiated from Wall Street to Main Street. Across the 9 United States, the result has been increasing business 10 bankruptcies and closures, lower consumer confidence and 11 spending, and job losses and rising unemployment. 12

13 For state governments, the financial crisis and economic 14 downturn have adversely impacted tax revenues and budgets. Most 15 states, like Hawaii, rely on income and sales taxes as their 16 main sources of revenues. The slowdown in employment and

consumer spending has reduced state revenues nationwide at a
 time when operating costs continue to rise.

Hawaii is experiencing a severe contraction in its visitor, 3 retail, and construction industries. As a consequence, the 4 council on revenues has revised its revenue projections downward 5 five times during 2008 and once again at the beginning of 6 January 2009. For fiscal year 2008-2009 alone, these downward 7 projections result in a reduction totaling \$491,100,000. Based 8 on the council on revenues' January 2009 projections, the State 9 is faced with a general fund revenue shortfall of \$343,100,000 10 in fiscal year 2008-2009 if corrective action is not taken. 11 This emergency appropriation is necessary in order for the State 12 to address this shortfall. 13

SECTION 3. The legislature finds and declares that:
(1) The health care payments program (HMS 401) of the department of human services is essential to the public health, safety, and welfare of the people of the State of Hawaii;

21 program for fiscal year 2008-2009 due to the severe

economic downturn impacting the State that has reduced 1 state general fund revenues; 2 (3) The appropriation in this Act will assist in 3 addressing the critical budget shortfall facing the 4 State in fiscal year 2008-2009 by allowing moneys from 5 the emergency and budget reserve fund to be used as a 6 source of funding to replace the general funds that 7 are currently appropriated for the health care 8 payments program for fiscal year 2008-2009; and 9 The appropriation in this Act is consistent with the 10 (4) purposes of the emergency and budget reserve fund. 11 The purpose of this Act is to appropriate \$60,000,000 from 12 the emergency and budget reserve fund to replace general funds 13 14 appropriated in Act 213, Session Laws of Hawaii 2007, as amended by Act 158, Session Laws of Hawaii 2008, for the health care 15 payments program (HMS 401) of the department of human services 16 and, thereby, help to address the budget shortfall in fiscal 17 18 year 2008-2009.

SECTION 4. There is appropriated out of the emergency and
budget reserve fund the sum of \$60,000,000, or so much thereof
as may be necessary for fiscal year 2008-2009, for the health
care payments program (HMS 401). The funds are to be used to



1	replace a like amount of general funds currently appropriated
2	for the health care payments program.
3	The sum appropriated shall be expended by the department of
4	human services to carry out the purposes of this Act.
