(6) A single parent responsible for the care and custody 1 2 of a child under the age of six months."] Section 346-53, Hawaii Revised Statutes, is SECTION 2. 3 amended by amending subsection (a) to read as follows: 4 This subsection does not apply to general assistance 5 "(a) households without minor dependents. The standard of need shall 6 equal the poverty level established by the federal government in 7 2006, prorated over a twelve-month period based on family size. 8 The assistance allowance provided shall be based on a 9 10 percentage of the standard of need. For [exempt households] other work eligible households and non-work eligible households 11 and households in which all caretaker relatives are minors, 12 living independently with minor dependents and attending school, 13 the assistance allowance shall be set no higher than sixty-two 14 and one-half per cent and no lower than forty-four per cent of 15 the standard of need. For all other households, the assistance 16 allowance shall be set no higher than sixty-two and one-half per 17 cent of the standard of need and set no lower than thirty-four 18 per cent of the standard of need. The standard of need shall be 19 determined by dividing the 2006 federal poverty level by twelve 20 and rounding down the quotient. The remaining quotient shall be 21 multiplied by the per cent as set by the director by rules 22

Description:

Amends section 346-1, Hawaii Revised Statutes, by adding definitions of "work eligible household" and "other work eligible household" and repealing the definition of "exempt household" to be consistent with recent changes in federal regulations. Also amends section 346-53(a), Hawaii Revised Statutes, to be consistent with the new definitions.

JUSTIFICATION SHEET

DEPARTMENT: Human Services

TITLE: A BILL FOR AN ACT RELATING TO PUBLIC ASSISTANCE.

PURPOSE: To conform the temporary assistance for needy families program to federal code by adding three new definitions of "other work eligible household", "non-work eligible household", and "work-eligible household" and repealing the definition of "exempt household" in section 346-1, Hawaii Revised Statutes (HRS) and by adding the conforming language to section 346-53(a), Hawaii Revised Statutes.

MEANS: Amend sections 346-1 and 346-53(a), Hawaii Revised Statutes.

JUSTIFICATION: The proposed bill is a housekeeping measure to conform to the Code of Federal Regulations, 45 C.F.R. section 261.2(n), relating to the Temporary Assistance for Needy Families program, which established a definition of "work eligible individual" to be used in place of the term "non-exempt individual" effective February 5, 2008. The amendments to section 346-1 are meant to accurately reflect the correct terminology used in 45 C.F.R. section 261-2(n).

The amendments to section 346-1 and section 346-53(a), Hawaii Revised Statutes, will ensure that the same terminology is used in all statutes related to the Temporary Assistance for Needy Families program.

<u>Impact on the public</u>: Clarity on the eligibility requirements for the Temporary Assistance for Needy Families program.

Impact on the department and other agencies: State law will be consistent with federal rules.
