A BILL FOR AN ACT

RELATING TO VOLUNTEER MEDICAL ASSISTANCE SERVICES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 321, Hawaii Revised Statutes, is
2	amended by adding to part I a new section to be appropriately
3	designated and to read as follows:
4	§321- Volunteer medical assistance personnel. (a) This
5	section shall apply to all volunteer medical assistance
6	personnel including:
7	(1) Physicians;
8	(2) Psychologists;
9	(3) Nurses;
10	(4) Emergency medical technicians;
11	(5) Social workers; and
12	(6) Mobile intensive care technicians
13	licensed or certified in this State, or employed by a health
14	care facility, while providing volunteer assistance services on
15	behalf of the State or a county, including participation during

16 periods of assistance services and assistance training.

1	(b) All volunteer medical assistance personnel who are			
2	injured in the performance of duty pursuant to this section,			
3	including duty performed during periods of training, shall be			
4	entitled to the benefits in section 386-171.			
5	(c) Except in cases of wilful or criminal misconduct,			
6	gross negligence, or reckless misconduct, any volunteer medical			
7	assistance personnel providing volunteer assistance services			
8	shall not be liable for the death of or injury to persons, or			
9	for damage to property, as a result of any act or omission in			
10	the course of rendering volunteer medical assistance services			
11	pursuant to this section. No act or omission shall be imputed			
12	to the owner of any vehicle by reason of ownership thereof;			
13	provided that nothing in this section shall preclude recovery by			
14	any person for injury or damage sustained from the operation of

Description:

Provides for medical expenses and immunity from liability for licensed medical personnel providing volunteer medical services on behalf of the State or a county.

JUSTIFICATION SHEET

DEPARTMENT:	Health
TITLE:	A BILL FOR AN ACT RELATING TO VOLUNTEER MEDICAL ASSISTANCE SERVICES.
PURPOSE:	To extend immunity from liability for volunteer medical professionals to include non-emergency situations.
MEANS:	Add a new section to part I of chapter 321 and amend section 662D-3, Hawaii Revised Statutes.
JUSTIFICATION:	This measure would provide immunity from liability for licensed medical professionals providing volunteer services in non- emergency situations on behalf of the State or counties, such as school-based immunization clinics. Volunteer workers who hold medical licenses and who are performing volunteer activities within the scope of their license are indemnified under Hawaii law when responding to an emergency, but are not protected from liability if they are volunteering for the State for a non- emergency activity. Lack of coverage for professional liability may mean that these valuable workers will not participate as state volunteers, thereby limiting the ability of the State to draw upon their skills as a critical public health resource. <u>Impact on the public</u> : Medical professionals could volunteer their time without fear of exposure to undo risk, and the public at large could benefit from their donation of time and expertise. <u>Improved preparation for disaster response.</u> Improved ability to recruit and retain volunteer medical professionals.
