County Licenses; Department of Health Certificates

Description:

Repeals the requirement for a sanitation certificate to be issued for county business licenses for the operation of a lodging or tenement house, group home, group residence, group living arrangement, hotel, or boarding house. The City and County of Honolulu no longer requires business licenses for these facilities because of Act 35, Session Laws of Hawaii 2001, so the sanitation certificate is unnecessary for Oahu. The counties of Kauai, Maui, and Hawaii never required a sanitation certificate for these types of businesses.

DEPARTMENT: Health

TITLE: A BILL FOR AN ACT RELATING TO DEPARTMENT OF HEALTH CERTIFICATES.

PURPOSE: To repeal the requirement for a sanitation certificate from the Department of Health to be issued for the operation of a lodging or tenement house, group home, group residence, group living arrangement, hotel, or boardinghouse.

MEANS: Amend section 445-94, Hawaii Revised Statutes.

JUSTIFICATION: In the past, the certificate was required to obtain a business license for these facilities from the City and County of Honolulu. The certificate was not required for other counties. This requirement for a business license was repealed by the legislature by Act 35, Session Laws of Hawaii 2001. There is no longer a need for a sanitation certificate to be issued.

> Impact on the public: No impact to the public is anticipated. The department will continue inspections for licensed care homes and other domiciliary facilities it regulates under different laws.
