BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 200-41, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"[+]§200-41[+] Disposition by chairperson of certain
4	abandoned vessels. Any vessel which:
5	(1) Has been left unattended for a continuous period of

7	(2) Is within the waters of the State or on public

10	property, under the jurisdiction of the department,
11	may be caused by the chairperson to be taken into custody and
12	disposed of pursuant to this part. All other vessels abandoned
13	on other public property or on private property may be the
14	responsibility of the property owner.

3	SECTION 3. Section 200-51, Hawaii Revised Statutes, is
4	amended to read as follows:

6	on premises of vessel repair business, private marinas, [ex]
7	yacht clubs[-], or other property. When any person abandons a
8	vessel upon the premises of a vessel repair business, a private
9	marina, [or other property, the owner of the
10	vessel repair business or private marina, or the owner's
11	representative, or the designated representative of the yacht
12	club, or the owner of the other property, may sell or dispose of
13	the vessel in accord with this part."

PURPOSE:

To clarify the responsibility for disposing of any abandoned vessel within the State.

MEANS:

Amend section 200-41, the title of part IV of chapter 200, and section 200-51, Hawaii

Revised Statutes (HRS).

JUSTIFICATION:

Current statutes place the burden of disposal of all abandoned vessels on the Department, regardless if the vessels lie abandoned on public lands under another agencies' jurisdiction or on private lands. The Department has the ability to take boats off reefs but not the equipment or expertise to remove abandoned boats on public streets. The disposition is both costly and time-consuming for the Department. This bill clarifies that the Department shall only be responsible for the disposition of vessels abandoned on lands and waters under its jurisdiction.

Section 200-51, HRS, specifically provides that when any person abandons a vessel upon the premises of a vessel repair business, a private marina, a yacht club, the owner of the business or private marina, or the owner's representative, or the designated representative of the yacht club, may sell or dispose of the vessel in accord with this part. This bill proposes to expand the authority to sell or dispose of a vessel abandoned on other property to the owners of the other property.

Impact on the public: None.

Impact on the department and other agencies: Would release the Department from having to



pay for the disposing of abandoned vessels on lands and water not under its jurisdiction.

Approval of this proposed bill would release the Department from the time-consuming process of disposing of abandoned vessels on lands and waters not under its jurisdiction. Additionally, this would free the Department from having to pay for the disposal of abandoned vessels on lands and waters not under its jurisdiction.
