(a) Except for the director and employees of the 4 department of public safety, members of the Hawaii paroling 5 authority, and those persons specified in section 353-29, no 6 7 person shall enter or remain on the grounds of any state correctional facility unless permission to so enter or remain 8 has been obtained from the administrator of the correctional 9 facility, the administrator's designated representatives, or the 10 director. 11

(b) Entry of any person or vehicle to state correctional
or detention facility grounds may be conditioned upon a search
for weapons or contraband.

15 [(b)] (c) Signs shall be posted at reasonable intervals

JUSTIFICATION SHEET

DEPARTMENT: Public Safety

TITLE: A BILL FOR AN ACT RELATING TO RESTRICTED ACCESS TO CORRECTIONAL FACILITIES.

PURPOSE: Expressly grants authority for correctional staff to search persons and vehicles that enter on state correctional facility grounds.

MEANS: Amend section 353-11.5, Hawaii Revised Statutes.

Correctional staff in the Department of JUSTIFICATION: Public Safety (PSD) are not law enforcement personnel. Therefore, they have no authority to search any person or vehicle that brings weapons or contraband on correctional facility grounds without this authority. There has been a history of contraband being introduced into correctional facilities in PSD. This bill will assist staff in combating the introduction of contraband and/or weapons, and more importantly assist staff in making the facilities safer and more secure for both staff and inmates.

> <u>Impact on the public</u>: This bill will provide a means to make correctional facilities safer and more secure for the public, inmates and staff. This is clearly a measure to ensure public safety.

Impact on the department and other agencies: This measure will provide the department with authority to perform the necessary measures to ensure safety and security. The measure would assist in the prosecution of anyone attempting to smuggle contraband into the facilities. This measure would also assist in clarifying legal authority to search persons and vehicles on state grounds, since the manifest intent of the Page 2

measure is to give correctional staff authority to do so.
