BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 291C-197, Hawaii Revised Statutes, is
 amended to read as follows:

3 "§291C-197 Driving mopeds on bicycle lanes and paths.
4 (a) Wherever bicycle lanes are provided on the roadway, <u>two-</u>
5 <u>wheeled</u> moped drivers shall use such bicycle lanes. <u>A three-</u>
6 wheeled moped shall not be driven in a bicycle lane.

7 (b) The director of transportation by rule and the 8 counties by ordinance may with respect to bicycle paths under 9 their respective jurisdictions restrict or prohibit the use of 10 such bicycle paths by mopeds. Signs clearly visible to an 11 ordinarily observant person indicating the restriction or 12 prohibition shall be placed along bicycle paths so designated 13 and every two-wheeled moped driver shall obey the directions 14 thereof. Three-wheeled mopeds shall not use bicycle paths. 15 [(c) This section shall not apply to a three wheeled 16 moped.]"

JUSTIFICATION SHEET

DEPARTMENT: Transportation

TITLE: A BILL FOR AN ACT RELATING TO MOPEDS.

PURPOSE: Prohibit three-wheeled mopeds from using bike lanes and bike paths.

- MEANS: Amend section 291C-197, Hawaii Revised Statutes.
- JUSTIFICATION: Three-wheeled mopeds provide a relatively inexpensive, fuel-efficient means of transportation but because they are wider than two-wheeled mopeds, they do not mix well in a confined area such as a bike lane or bike path. Prohibiting the use of threewheeled mopeds on bike lanes and bike paths will promote safety in these areas.

<u>Impact on the public</u>: Bicyclists who use the bike lanes and bike paths will not be required to compete for space with threewheeled mopeds in these areas.

Impact on the department and other agencies: No impact is anticipated.
