# A BILL FOR AN ACT

RELATING TO THE HOMELESS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that many homeless		
2	persons are presently stranded in the state and are separated		
3	from their families and relatives in their home state but lack		
4	independent financial resources to reunite with those family		
5	members.		
6	The purpose of this Act is to establish a return-to-home		
7	program for the homeless.		
8	SECTION 2. Chapter 356D, Hawaii Revised Statutes, is		
9	amended by adding a new subpart to part VII to be appropriately		
10	designated and to read as follows:		
11	" . Return-To-Home Program		
12	<b>§356D- Return-to-home program.</b> (a) There is		
13	established within the authority a voluntary homeless assistance		
14	program to be known as the return-to-home program, to provide		
15	the eligible homeless with assistance in being reunited with		
16	their families and relatives in the person's home state. The		
17	authority shall administer the program and adopt the standards

1	(b)	No person who is homeless shall be eligible to
2	participa	te in the program unless:
3	(1)	The person's participation is completely voluntary;
4	(2)	The person has a support system in place in the
5		person's home state that is willing to receive and
6		accommodate the person;
7	(3)	The person, if on parole, probation, or awaiting a
8		court hearing or sentencing, has proper clearance from
9		the court to participate in the program; and
10	(4)	The person is indigent and lacks the financial
11		resources necessary to secure transportation to return
12		to the person's home state.
13	(c)	The authority shall actively seek the participation of
14	local air	lines, cruise lines, charter companies, homeless
15	programs,	travel agencies, and the visitor industry to implement
16	and coord	inate the program.

18	with nece	ssary and proper preparations for the return trip,
19	including	proper identification, orientation relating to airport
20	security,	and the basics of personal care, and shall follow up
