A BILL FOR AN ACT

RELATING TO PUBLIC EMPLOYMENT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the employer-union
- 2 health benefits trust fund staff is encountering difficulties
- 3 performing its duties. The legislature believes that these
- 4 difficulties are the result of an increased and more complex
- 5 workload, shortage of personnel, and absence of board and
- 6 administrative leadership.
- 7 The legislature further finds that the enabling law for the
- 8 voluntary employees' beneficiary association trust, an
- 9 alternative health-benefits system utilized by the employee
- 10 organization for public school teachers, will sunset on July 1,
- 11 2010. The legislature finds that the employer-union health
- 12 benefits trust fund staff will have extreme difficulty
- 13 transitioning public school teachers and their dependents from
- 14 the voluntary employees' beneficiary association trust to the
- 15 employer-union health benefits trust fund on July 1, 2010, while
- 16 also performing their normal duties. The legislature does not
- 17 want to place an excessive burden on the employer-union health

- 1 benefits trust fund staff or cause uncertainty for public school
- 2 teachers and their dependents who will have to transition from
- 3 the voluntary employees' beneficiary association trust.
- 4 Thus, the legislature finds that the voluntary employees'
- 5 beneficiary association trust enabling law should be extended by
- 6 two years and additional employer-union health benefits trust
- 7 fund personnel positions should be funded to assist in the
- 8 performance of duties of the trust fund.
- 9 The purpose of this Act is to:
- 10 (1) Extend the enabling law for the voluntary employees'
- 11 beneficiary association trust by two years in order to
- provide for a smoother transition to the Hawaii
- employer-union health benefits trust fund; and
- 14 (2) Appropriate funds for five permanent positions for the
- performance of employer-union health benefits trust
- 16 fund duties.
- 17 SECTION 2. Act 245, Session Laws of Hawaii 2005, section
- 18 8, as amended by Act 294, Session Laws of Hawaii 2007, section
- 19 2, as amended by Act 16, Session Laws of Hawaii 2008, section
- 20 18, as amended by Act 5, First Special Session Laws of Hawaii
- 21 2008, section 1, is amended to read as follows:

- 1 "SECTION 8. This Act shall take effect upon its approval,
- 2 for the purpose of establishing a voluntary employees'
- 3 beneficiary association trust pilot program in March, 2006 and
- 4 shall be repealed on [July 1, 2010;] July 1, 2012; provided that
- 5 sections 89-2, 89-3, 89-6, and 89-9, Hawaii Revised Statutes,
- 6 are reenacted in the form in which they read on the day before
- 7 the effective date of this Act; and provided further that the
- 8 amendments made to section 89-6, Hawaii Revised Statutes, by Act
- 9 202, Session Laws of Hawaii 2005, shall not be repealed when
- 10 that section is reenacted on July 1, 2009."
- 11 SECTION 3. There is appropriated out of the Hawaii
- 12 employer-union health benefits trust fund of the State of Hawaii
- 13 the sum of \$ or so much thereof as may be necessary
- 14 for fiscal year 2010-2011 for five permanent positions under the
- 15 Hawaii employer-union health benefits trust fund to assist in
- 16 the performance of duties of the trust fund.
- 17 The sum appropriated shall be expended by the Hawaii
- 18 employer-union health benefits trust fund for the purposes of
- 19 this Act.
- 20 SECTION 4. Statutory material to be repealed is bracketed
- 21 and stricken. New statutory material is underscored.
- 22 SECTION 5. This Act shall take effect on July 1, 2020.
