BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

The sums appropriated in sections 4 and 5 shall 11 be expended by the county of Maui for the purposes of this Act. SECTION 7. There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 19 or so much thereof as may be necessary for fiscal year 2009-2010 for a 20 grant-in-aid to the office of the prosecuting attorney of the 21

1 county of Kauai for the victim witness assistance program, including the hiring of necessary staff. 2 3 SECTION 9. The sums appropriated in sections 7 and 8 shall be expended by the county of Kauai for the purposes of this Act. 4 SECTION 10. There is appropriated out of the general 5 revenues of the State of Hawaii the sum of \$ 6 or so much thereof as may be necessary for fiscal year 2009-2010 for a 7 grant-in-aid to the office of the prosecuting attorney of the 8 county of Hawaii for the career criminal prosecution unit, 9 including the hiring of necessary staff. 10 SECTION 11. There is appropriated out of the general 11 revenues of the State of Hawaii the sum of \$ 12 or so much thereof as may be necessary for fiscal year 2009-2010 for a 13 grant-in-aid to the office of the prosecuting attorney of the 14 county of Hawaii for the victim witness assistance program, 15 16 including the hiring of necessary staff.

17 SECTION 12. The sums appropriated in sections 10 and 11
18 shall be expended by the county of Hawaii for the purposes of
