1	SECTION 1. Chapter 150A, Hawaii Revised Statutes, is

9	(1) A person responsible for paying the freight charges to

11	shall be assessed a fine of \$ for every one
12	thousand pounds of freight or part thereof; and
13	(2) A transportation company that does not:
14	(A) Bill the fee to the person responsible for paying
15	the freight charges to the transportation company
16	within fifteen days of the delivery of the

1	(B) Remit the fee to the department within forty-five
2	days of collecting the fee from the person
3	responsible for paying the freight charges to the

8	deposited into the pest inspection, quarantine, and eradication
9	fund under section 150A-4.5."
10	SECTION 2. Section 150A-2, Hawaii Revised Statutes, is
11	amended by adding two new definitions to be appropriately
12	inserted and to read as follows:
13	" "Cement bulk freight" means unpackaged, homogenous cement,
14	without mark or count and usually free-flowing, bought and sold
15	by weight or volume.
16	"Liquid bulk freight" means unpackaged, homogenous liquid
17	goods, without mark or count and usually free-flowing, bought
18	and sold by weight or volume, such as oil."
19	SECTION 3. Section 150A-5.3, Hawaii Revised Statutes, is
20	amended to read as follows:
21	"§150A-5.3 Inspection, quarantine, and eradication service
22	fee and charge. There is imposed a fee for the inspection,

1 quarantine, and eradication of invasive species contained in any 2 freight, including but not limited to marine commercial 3 container shipment, air freight, or any other means of 4 transporting freight, foreign or domestic, that is brought into 5 the State[-], except for liquid bulk freight and cement bulk 6 freight. The fee shall be paid by the person responsible for paying the freight charges to the transportation company, who 7 shall collect the fee and forward the payment to the department 8 9 at the port of disembarkation; provided that the transportation 10 company shall not be liable for any fee that is not paid by the 11 person responsible for paying the freight charges to the 12 transportation company. The department shall deposit the fee 13 into the pest inspection, quarantine, and eradication fund under 14 section 150A-4.5.

15 The fee shall be assessed on the net weight of the imported 16 freight computed on the basis of 50 cents for every one thousand 17 pounds of freight brought into the State, or part thereof."

18 SECTION 4. Statutory material to be repealed is bracketed19 and stricken. New statutory material is underscored.
