RELATING TO TRANSPORTATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 291-24, Hawaii Revised Statutes, is amended to read as follows: 2 "§291-24 Motorcycles, motor scooters, and mopeds, noisy 3 mufflers; penalty. (a) Every motorcycle, motor scooter, and 4 moped moving under its own power on a public highway shall at 5 all times be equipped with a muffler in constant operation to 6 7 prevent any excessive or unusual noise and no such muffler or 8 exhaust system shall be equipped with a cutout, bypass, or 9 similar device. No person shall modify the exhaust system of a 10 motorcycle, motor scooter, or [a] moped in a manner [which] that 11 will amplify or increase the noise emitted by the motor of 12 [such] the motorcycle, motor scooter, or moped above that 13 emitted by the muffler originally installed on the motorcycle, 14 motor scooter, or moped [except a]. 15 (b) Subsection (a) notwithstanding, a motorcycle, motor 16 scooter, or moped that: 17 (1)Has three wheels:
