### A BILL FOR AN ACT

RELATING TO CRIME.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 712, Hawaii Revised Statutes, is			
2	amended by adding four new sections to be appropriately			
3	designated and to read as follows:			
4	<u>§712-</u> Loitering while using or possessing an illegal			
5	drug. (1) A person is guilty of loitering while using or			
6	possessing an illegal drug if the person remains or wanders in			
7	Ala Moana Park while unlawfully using or possessing a dangerous,			
8	detrimental, or harmful drug.			
9	(2) Loitering while using or possessing an illegal drug is			
10	a misdemeanor.			
11	(3) As used in this section:			
12	"Ala Moana Park" means that area of Oahu bounded by Ala			
13	Moana boulevard, Kewalo basin, Atkinson drive, and the ocean.			
14	"Dangerous drug" shall have the same meaning as in section			
15	712-1240.			
16	"Detrimental drug" shall have the same meaning as in			
17	section 712-1240.

3	§712- Loitering while begging or soliciting alms. (1)			
4	A person is guilty of loitering while begging or soliciting alms			
5	if the person remains or wanders in Ala Moana Park while begging			
6	or soliciting alms.			
7	(2) Loitering while begging or soliciting alms is a			
8	violation.			
9	(3) As used in this section, "Ala Moana Park" means that			
10	area of Oahu bounded by Ala Moana boulevard, Kewalo basin,			
11	Atkinson drive, and the ocean.			
12	<b>§712-</b> Criminal nuisance in the first degree. (1) A			
13	person is guilty of criminal nuisance in the first degree if the			
14	person intentionally, knowingly, or recklessly operates or			
15	maintains any premises or place in Ala Moana Park where persons			
16	come or gather for the purpose of engaging in the unlawful sale			
17	or distribution of a dangerous, detrimental, or harmful drug.			
18	(2) Criminal nuisance in the first degree is a class A			
19	felony.			
20	(3) As used in this section:			
21	"Ala Moana Park" means that area of Oahu bounded by Ala			
22	Moana boulevard, Kewalo basin, Atkinson drive, and the ocean.
