## A BILL FOR AN ACT

RELATING TO MOTOR VEHICLES.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to permit towing 2 companies to add the applicable general excise tax to the fees 3 charged to the owner of a motor vehicle left unattended on 4 private or public property without authorization of the owner or 5 occupant of the property. Previously, towing companies were 6 advised by authorities that the general excise tax could not be 7 added to the towing fees. 8 Section 290-11, Hawaii Revised Statutes, is SECTION 2. 9 amended by amending subsection (b) to read as follows: 10 "(b) Towing companies engaged by the owner, occupant, or 11 person in charge of the property shall: 12 Charge not more than \$65 for a tow, or \$75 for a tow (1)13 using a dolly, plus a mileage charge of \$7.50 per mile 14 towed and \$25 per day or fraction thereof for storage 15 for the first seven days and \$20 per day 16 thereafter [-], plus a charge that reflects the amount 17 of the general excise tax and county surcharge, if 18 applicable, relative to the charges. occurs between the hours of six o'clock p.m. and six 1 2 o'clock a.m., from Monday through Thursday and from 3 six o'clock p.m. Friday to six o'clock a.m. Monday, the towing company shall be entitled to an overtime 4 5 charge of \$15. If the vehicle is in the process of 6 being hooked up or is hooked up to the tow truck and 7 the owner appears on the scene, the towing company shall unhook the vehicle and shall not charge any fee 8 to the owner of the vehicle. In the case of a 9 10 difficult hookup, meaning an above or below ground 11 hookup in a multilevel facility, a towing surcharge of \$30 shall be applicable; 12

13 (2)Determine the name of the legal owner and the 14 registered owner of the vehicle from the department of 15 transportation or the county department of finance. 16 The legal owner and the registered owner shall be 17 notified in writing at the address on record with the 18 department of transportation or with the county 19 department of finance by registered or certified mail 20 of the location of the vehicle, together with a 21 description of the vehicle, within a reasonable period

1 not to exceed fifteen days following the tow. The notice shall state: 2 3 (A) The maximum towing charges and fees allowed by law; 4 5 (B) The telephone number of the consumer information 6 service of the department of commerce and 7 consumer affairs; and That if the vehicle is not recovered within 8 (C) 9 thirty days after the mailing of the notice, the 10 vehicle shall be deemed abandoned and will be 11 sold or disposed of as junk. 12 Where the owners have not been so notified, then the 13 owner may recover the owner's [car] vehicle from the 14 towing company without paying tow or storage fees; 15 provided that the notice need not be sent to a legal 16 or registered owner or any person with an unrecorded 17 interest in the vehicle whose name or address cannot 18 be determined. Absent evidence to the contrary, a 19 notice shall be deemed received by the legal or 20 registered owner five days after the mailing. A 21 person, including but not limited to the owner's or 22 driver's insurer, who has been charged in excess of
