A BILL FOR AN ACT

RELATING TO HAWAII COMMUNITY DEVELOPMENT AUTHORITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that there are five
 voting members on the Hawaii community development authority
 that are appointed to represent the Kalaeloa community
 development district. Two of the five members are the
 chairperson of the Hawaiian homes commission and the director of
 the city and county of Honolulu department of planning and
 permitting.

8 The legislature further finds that taking into account the 9 other heavy responsibilities that their positions may require of 10 them, in many instances, these officials find it difficult to 11 attend Hawaii community development authority meetings; however, 12 section 206E-191(c), Hawaii Revised Statutes, does not permit 13 them to appoint a designated representative. As a result, at 14 times, a quorum is difficult to achieve, thereby delaying 15 important discussions and decisions.

16 The purpose of this Act is to amend section 206E-191(c), 17 Hawaii Revised Statutes, to allow the chairperson of the 18 Hawaiian homes commission and the director of the city and HB LRB 09-1797.doc

5 SECTION 2. Section 206E-191, Hawaii Revised Statutes, is
6 amended by amending subsection (c) to read as follows:

7 "(c) Five additional voting members [shall], except as 8 otherwise provided in this subsection, shall be appointed to the 9 authority by the governor to represent the Kalaeloa community 10 development district. These members shall be considered in 11 determining quorum and majority only on issues relating to the 12 Kalaeloa community development district, and may vote only on 13 issues relating to the Kalaeloa community development district. 14 These members shall consist of:

15 (1) The chairperson of the Hawaiian homes commission[+] or
16 the chairperson's designated representative who shall
17 serve as an ex officio, voting member;
18 (2) The director of the city and county of Honolulu
19 department of planning and permitting[+] or the
