A BILL FOR AN ACT

RELATING TO HAWAII'S ECONOMY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. If Hawaii is to be a player in a global 2 economy, it is essential that an assessment of the State's 3 economic conditions and prospects be assessed in an objective 4 manner to address serious challenges facing the State, including 5 but not limited to the overall high cost of living and doing 6 business in the State, the high costs of housing and 7 consumables, outward migration of skilled and knowledge workers, 8 and outward investment.

9 In view of the heightened competiveness facing individual 10 states and countries, it is critical that the State's leaders 11 have a clear understanding of the global forces that influence 12 the State's economy, the State's relative competitiveness, and 13 policies and options that are available for placing the State on 14 an optimal development path.

15 The purpose of this Act is to make an appropriation to 16 allow the legislative reference bureau to contract with an out-17 of-state contractor to undertake a diagnostic assessment of the 18 conditions, challenges, and opportunities facing the State. HB LRB 09-0184-1.doc

1 SECTION 3. There is appropriated out of the general revenues of the State of Hawaii the sum of \$200,000 or so much 2 3 thereof as may be necessary for fiscal year 2009-2010 for 4 contracting the services of economic consultants with expertise 5 in international and local economic analysis to undertake the 6 diagnostic assessment set forth in section 2. To ensure the 7 objectivity of the analysis, the principal consultant selected 8 shall be an out-of-state economic consultant. 9 The sum appropriated shall be expended by the legislative 10 reference bureau for the purposes of this Act. 11 SECTION 4. Not less than twenty days prior to the 12 convening of the regular session of 2011, the legislative 13 reference bureau shall submit the diagnostic assessment to the 14 legislature, along with any recommended proposed legislation. 15 SECTION 5. This Act shall take effect on July 1, 2009. 16
