#### A BILL FOR AN ACT

RELATING TO MOPEDS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- SECTION 1. Section 249-2, Hawaii Revised Statutes, is
  amended to read as follows:

  "\$249-2 Imposition of tax. Except as otherwise provided
  in sections 249-1 to 249-13, and except in the case of antique
  motor vehicles which shall be subject to an annual tax of \$10 in
  lieu of the annual tax otherwise imposed by this section, all
- 7 vehicles, mopeds, and motor vehicles as defined in section 249-
- $oldsymbol{8}$  1, shall be subject to an annual tax, computed, except for the
- 9 minimum tax provided for in section 249-13 according to the net
- 10 weight of each vehicle at a rate determined as hereinafter
- 11 provided in section 249-13. The tax shall become due and
- 12 payable on January 1 and must be paid before April 1, in each
- 13 year. The tax shall be paid by the owner of each vehicle in the
- 14 county in which the vehicle is located at the time of
- 15 registration, whether the original registration or any
- 16 subsequent registration, and shall be collected by the director
- 17 of finance of such county; provided that if any such vehicle is
- 18 transported to another county after the payment of such tax, no HB HMIA 77-2009



- 1 additional tax shall be imposed on such vehicle for the
- 2 remaining period of the year for which such tax has been paid."
- 3 SECTION 2. Section 249-4, Hawaii Revised Statutes, is
- 4 amended to read as follows:
- 5 "\$249-4 Exemptions for new vehicles and official vehicles.
- 6 All new vehicles and mopeds, otherwise taxable under sections
- 7 249-1 to 249-13, in stock for purposes of sale, shall be exempt
- 8 from the tax herein provided, and number plates for all these
- 9 vehicles and mopeds may be issued as now and hereafter provided
- 10 by ordinance of the county. All motor vehicles owned or leased
- 11 for twelve months or longer by the State or any county and all
- 12 motor vehicles and motorcycles owned or leased for twelve months
- or longer by police officers of the State or any county that
- 14 actually are used by them in their travel on official business
- 15 shall be exempt from the tax herein provided, and number plates
- 16 for all these vehicles may be issued as provided by ordinance of
- 17 the county; provided that the director of finance may charge the
- 18 State an amount equal to the cost to the county of the number
- 19 plates issued to the State."
- 20 SECTION 3. Section 249-5.5, Hawaii Revised Statutes, is
- 21 amended to read as follows:

"$249-5.5 Stored vehicles. (a) All vehicles and mopeds

    taxable under sections 249-1, 249-2, 249-4 and 249-6 to 249-13,

    which are stored so that they are not used for transportation,

         SECTION 4. Section 249-7, Hawaii Revised Statutes, is

         "$249-7 Number plates. (a) Upon receipt of the tax the

    director of finance shall number and register the vehicle or
    moped in the owner's name in a permanent record or book to be

    kept by the director for this purpose, and shall furnish the

    owner thereof with a receipt showing upon its face the license

    number issued for the vehicle or moped and the fact that the

    license tax has been paid thereon for the whole or the remainder

    of the current year in which the receipt is issued.

    director of finance shall also furnish the owner, upon the

    original registration of the vehicle or moped, two number plates

- 1 year of expiration shall be provided to the owner. Transfer of
- 2 current number plates, tag, or emblem, except as authorized by
- 3 this chapter or by chapter 286, is punishable by a fine of not
- 4 more than \$50 for each offense.
- 5 (b) Upon an original registration the director of finance
- 6 shall fix, and shall charge to the owner, a fee equal to the
- 7 cost of the number plate and tag or emblem plus the
- 8 administrative cost of furnishing the plate and tag or emblem
- 9 and effecting the registration. Upon the issuance of a new
- 10 series of number plates as determined by the directors of
- 11 finance of each county through majority consent, the director of
- 12 finance shall charge the owner a fee equal to the costs of the
- 13 number plate plus the administrative cost of furnishing the
- 14 plates. Upon issuing a tag or emblem, the director of finance
- 15 shall charge the owner a fee of 50 cents. The owner shall
- 16 securely fasten the number plates on the vehicle, one on the
- 17 front and the other on the rear, at a location provided by the
- 18 manufacturer or in the absence of such a location upon the
- 19 bumpers of the vehicle and in conformance with section 291-31,
- 20 in such a manner as to prevent the plates from swinging. Number
- 21 plates shall at all times be displayed entirely unobscured and
- 22 be kept reasonably clean. In the case of trailers,

- 1 semitrailers, mopeds, or motorcycles, one plate shall be used
- 2 and it shall be fastened to the rear thereof at a location
- 3 provided by the manufacturer or in the absence of such a
- 4 location at the rear thereof, and in the case of motorcycles in
- 5 conformance with section 291-31.
- 6 (c) Upon the issuance of the tag or emblem the owner shall
- 7 affix the tag or emblem to the top right portion of the rear
- 8 number plate, except that all vehicles owned by the State, any
- 9 county government, any board of water supply, and official
- 10 representatives of any foreign governments shall be issued
- 11 registrations which need be renewed only in the new plate issue
- 12 year.
- 13 (d) After the initial payment of the tax and the original
- 14 registration of a vehicle or moped as herein specified, a motor
- 15 vehicle shall not be required to be reweighed in any succeeding
- 16 year unless it has been so altered or changed as to increase or
- 17 diminish its weight. No new number plates shall, however, be
- 18 issued to a new owner except as provided in sections 249-7.5 and
- **19** 249-8.
- 20 (e) If an owner of a vehicle or moped registered in any
- 21 county, upon the disposition of the vehicle or moped, requests
- 22 that the license plates furnished to the owner with respect to

- 1 the registration of the vehicle or moped be assigned to another
- 2 vehicle or moped subsequently acquired by the owner, the
- 3 assignment may be made by the director of finance at the
- 4 director's discretion. To defray additional administrative
- 5 costs incurred by acceding to those requests, the director of
- 6 finance shall charge a fee of \$5 for each reassignment of
- 7 license plates, in addition to the fee for registration. The
- 8 procedure for registering the vehicles shall otherwise be
- 9 identical with that provided by this section."
- 10 SECTION 5. Section 249-8, Hawaii Revised Statutes, is
- 11 amended to read as follows:
- "\$249-8 Replacements for lost or damaged plates, tags, or
- 13 emblems. Upon the loss, defacement, or destruction of a number
- 14 plate or plates, tag or emblem issued upon any vehicle or moped,
- 15 or where the number plate, tag, or emblem has become illegible
- 16 or is in such condition as to be difficult to read, the owner of
- 17 the vehicle shall make application for a new number plate or
- 18 plates, tag, or emblem upon such form as shall be prescribed by
- 19 the county director of finance. The owner shall be required, in
- 20 addition to other requirements, to make a complete statement as
- 21 to the cause of the loss, defacement, or destruction of the
- 22 original number plate or plates, tag, or emblem. Upon the



1 filing of such form, the director of finance shall issue a new number plate or plates, tag, or emblem and shall charge the 2 3 owner a fee to be fixed by the director of finance equal to the 4 costs of the number plate, tag, or emblem, plus the 5 administrative cost of furnishing the plate, tag, or emblem and effecting the replacement." 6 7 SECTION 6. Section 249-9, Hawaii Revised Statutes, is 8 amended by amending subsection (a) to read as follows: 9 "\$249-9 Number plates; purchase. (a) The number plates 10 hereinabove referred to shall be used upon all vehicles or 11 mopeds for which a tax has been paid pursuant to sections 249-1 12 to 249-13. All such plates shall: 13 (1) Bear the word "Hawaii" along the upper portion of the 14 plate and the words "Aloha State" along the lower 15 portion of the plate; 16 (2) Have a distinct contrast between the color of the 17 plate and the numerals and letters thereon; and 18 (3)Be of such shape, size, and color, and with such 19 arrangements of letters and numbers as may, subject to 20 sections 249-1 to 249-13, be determined by the 21 directors of finance of each county through majority

consent.

The numerals on all such plates shall be not less than three 2 inches in height and the strokes thereof not less than three-3 eighths inch in width, except in the case of motorcycles, in which case the numerals shall not be less than one inch in 4 5 height and the strokes thereof not less than one-eighth inch in 6 width. 7 The director of finance of the city and county of Honolulu 8 shall contract annually on behalf of the counties for the 9 purchase of all number plates, tags, or emblems required. 10 council of each county shall appropriate and cause to be paid 11 over to the party with whom the director of finance of the city 12 and county of Honolulu shall contract, or to the director of 13 finance of the city and county of Honolulu as the director may 14 direct, such sum or sums as the director of finance of the city 15 and county of Honolulu shall determine to be the county's 16 proportionate share of the expense of such contract and the 17 charges connected therewith. The contract shall be made by the 18 director of finance of the city and county of Honolulu as agent 19 of the several counties, and the proportionate liability of each 20 county shall be stated in the contract. Notwithstanding any 21 other provision of the law, the contract shall constitute a 22 valid obligation of each county for its proportionate share."



1 SECTION 7. Section 249-11, Hawaii Revised Statutes, is 2 amended by amending subsection (a) to read as follows: "\$249-11 Fraudulent use of plates, tags, or emblems and 3 other misdemeanors; penalties. (a) Any person who 4 5 manufactures, sells, or distributes vehicle or moped number plates, tags, or emblems of a design and size similar to the 6 7 currently issued series of number plates, tags, or emblems 8 authorized by the director of finance, or who attaches to and 9 uses on any vehicle or moped plates, tags, or emblems not 10 furnished in accordance with sections 249-1 to 249-13 or 286-53, 11 or who fraudulently uses such number plates, tags, or emblems 12 upon any vehicle other than the one for which the number plates, 13 tags, or emblems were issued, or who molests or disturbs any 14 vehicle which has been seized pursuant to sections 249-1 to 249-15 13, or any person who knowingly uses a motor vehicle or moped, 16 the tax upon which is delinquent, upon public highways of this 17 State, or any director of finance who issues a certificate of 18 registration or number plates, tags, or emblems to any person 19 who has not paid the tax required by sections 249-1 to 249-13, 20 or any person who violates any of the provisions of such 21 sections, shall be fined not more than \$500."

SECTION 8. Section 249-13, Hawaii Revised Statutes, is 1 amended by amending subsection (a) to read as follows: 2 3 "\$249-13 Determination of rate. (a) The council shall determine the rate and the minimum tax at which all vehicles, 4 5 mopeds, and motor vehicles in each respective county shall be 6 taxed as provided by section 249-2. In making the 7 determination, the rate and minimum tax on trucks or 8 noncommercial motor vehicles shall be in accordance with 9 subsection (b). The rate and minimum tax shall be established 10 by ordinance, provided that prior to final action thereon a 11 public hearing shall be held on the proposed rate. Public 12 notice of the time and place of the hearing shall be given at 13 least ten days prior to the hearing in the county. After the 14 public hearing the council may fix the rate and the minimum tax 15 at any amount deemed necessary, but the rate and the minimum 16 shall not be higher than that originally proposed when the 17 notice of public hearing was given. Any rate and minimum tax so 18 established shall be effective as of January 1 of the year following the date of enactment of the ordinance." 19 20 SECTION 9. Section 249-14, Hawaii Revised Statutes, is 21 amended by amending subsection (b) to read as follows:

1 "(b) An owner of a bicycle having two tandem wheels that are less than twenty inches in diameter is not required to 2 3 register such bicycle, but may do so to facilitate the return of recovered stolen bicycles by payment of the registration fee. 4 The fee collected shall not be refunded or prorated. Upon 5 6 receipt of the fee, the director of finance shall number and 7 register each bicycle and moped for which the fee is paid, in 8 the owner's name and furnish the owner with a metallic tag or 9 decal for each bicycle or moped which shall be attached to the 10 bicycle or moped. On bicycles the decal shall be affixed to the 11 upright post attached to the sprocket facing in the forward 12 direction. [On mopeds the decal shall be affixed to the lower 13 portion of the rear fender facing rearward.] Upon initial 14 registration by an owner or transferee, the director of finance 15 shall require proof of ownership and require the owner to 16 furnish verification of the serial number and description 17 contained in the proof of ownership and application for 18 registration. The metallic tags or decals shall be in a form as 19 the director of finance shall from time to time prescribe. It 20 shall be the duty of the director of finance of each county to 21 purchase a sufficient number of these tags or decals."

- SECTION 10. Section 249-14.5, Hawaii Revised Statutes, is 1 2 amended to read as follows: "\$249-14.5 New bicycles and mopeds. All new bicycles and 3 mopeds, otherwise requiring the payment of fees under section 4 5 249-14, held in stock for purposes of sale shall be exempt from the fee. At the time of first sale, the dealer selling the new 6 7 bicycle or moped shall: 8 Require the buyer to complete a license application 9 form furnished by the director of finance; 10 (2) Issue a copy of the completed form to the buyer; and 11 Transmit a copy of the completed form to the director (3)12 of finance with the required fees which the dealer has 13 collected from the buyer. 14 Upon receipt of the fee and the completed license application 15 form, the director of finance shall mail a tag or decal and 16 certificate of registration to the registered owner of a bicycle. Until the tag or decal is received, the bicycle [or 17 18 moped] owner shall keep a copy of the completed application form 19 upon the owner's person when riding the bicycle [or moped] on a 20 public street." 21 SECTION 11. Section 249-15, Hawaii Revised Statutes, is

amended to read as follows:

1 Seizure and sale. The directors of finance, any "§249-15 person authoritatively acting on behalf of the director of 2 3 finance, or any member of a police force of the several counties of the State may seize any bicycle or moped liable for the 4 5 payment of the required fees or which has no tag or decal or license plate affixed as required by section 249-7 or 249-14, 6 7 and may hold the bicycle or moped for a period of ten days, 8 during which time it shall be subject to redemption by its owner 9 on payment of the fee due and a penalty of \$1. All bicycles and 10 mopeds not so redeemed shall be sold by the county chief of 11 police or director of finance or their authorized 12 representative, at public auction after first giving five days 13 public notice of the time and place of sale in the county where 14 the sale is to be held. Sale shall be made for the best price 15 obtainable, which amount shall be forthwith paid over to the 16 director of finance, accompanied by a statement containing a 17 description of the bicycles or mopeds, their serial number, 18 makes, and any other marks of identification. The director of 19 finance, after deducting from the amount so received the amount 20 of the fee and penalty due and costs of giving public notice, 21 shall pay any surplus to the previous registered owners of the 22 bicycles or mopeds. If at the expiration of ninety days the



- 1 previous registered owners remain unknown, the surplus shall be
- 2 paid into the treasury of the county, as a government
- 3 realization, and all claims to the sums shall be forever
- 4 barred."
- 5 SECTION 12. Section 249-16, Hawaii Revised Statutes, is
- 6 amended to read as follows:
- 7 "S249-16 Duplicate bicycle and moped tags and certificates
- 8 of registration. In the event that a bicycle [or moped] tag or
- 9 certificate of registration furnished under section 249-14 or
- 10 249-14.2 is lost, stolen, or mutilated, or becomes illegible,
- 11 the person to whom it was furnished may obtain a duplicate
- 12 thereof by presenting to the county director of finance the
- 13 number and registration of the bicycle [or moped] involved.
- 14 There shall be a charge of \$2 for the duplicate tag and \$5 for
- 15 the duplicate certificate of registration."
- 16 SECTION 13. Section 249-17, Hawaii Revised Statutes, is
- 17 amended to read as follows:
- 18 "\$249-17 False tag, bicycle or moped, penalty. Any person
- 19 who uses a tag not furnished in accordance with section 249-14,
- 20 or who counterfeits any such tag or who fraudulently removes
- 21 such a tag from any bicycle [or moped,] shall be fined not more
- 22 than \$500."
