RELATING TO EMPLOYER-UNION HEALTH BENEFITS.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The purpose of this Act is to assist in
reducing the State's projected expenditures in this time of dire
economic crisis.
SECTION 2. Section 87A-23, Hawaii Revised Statutes, is
amended to read as follows:
"\$87A-23 Health benefits plan supplemental to medicare.

7 The board shall establish a health benefits plan, which takes 8 into account benefits available to an employee-beneficiary and 9 spouse under medicare, subject to the following conditions:

There shall be no duplication of benefits payable 10 (1)under medicare. The plan under this section, which 11 12 shall be secondary to medicare, when combined with medicare and any other plan to which the health 13 14 benefits plan is subordinate under the National 15 Association of Insurance Commissioners' coordination 16 of benefit rules, shall provide benefits that 17 approximate those provided to a similarly situated beneficiary not eligible for medicare; 18

The State, through the department of budget and 1 (2)finance, and the counties, through their respective 2 departments of finance, shall pay to the fund a 3 contribution equal to an amount not less than the 4 medicare part B premium, for each of the following who 5 are enrolled in the medicare part B medical insurance 6 plan: (A) an employee-beneficiary who is a retired 7 employee, (B) an employee-beneficiary's spouse while 8 the employee-beneficiary is living, and (C) an 9 employee-beneficiary's spouse, after the death of the 10 employee-beneficiary, if the spouse qualifies as an 11 employee-beneficiary. For purposes of this section, a 12 "retired employee" means a retired [members] member of 13 14 the employees' retirement system; county pension system; or a police, firefighters, or bandsmen pension 15 system of the State or a county as set forth in 16 17 chapter 88[-]; provided that the member retired prior 18 to December 31, 2009. If the amount reimbursed by the fund under this section is less than the actual cost 19 of the medicare part B medical insurance plan due to 20 an increase in the medicare part B medical insurance 21 plan rate, the fund shall reimburse each employee-22

beneficiary and employee-beneficiary's spouse for the 1 cost increase within thirty days of the rate change. 2 Each employee-beneficiary and employee-beneficiary's 3 spouse who becomes entitled to reimbursement from the 4 fund for medicare part B premiums after July 1, 2006, 5 6 shall designate a financial institution account into which the fund shall be authorized to deposit 7 reimbursements. This method of payment may be waived 8 9 by the fund if another method is determined to be more 10 appropriate;

The benefits available under this plan, when combined 11 (3)with benefits available under medicare or any other 12 13 coverage or plan to which this plan is subordinate under the National Association of Insurance 14 Commissioners' coordination of benefit rules, shall 15 approximate the benefits that would be provided to a 16 17 similarly situated employee-beneficiary not eligible for medicare; 18

19 (4) All employee-beneficiaries or dependent-beneficiaries
20 who are eligible to enroll in the medicare part B
21 medical insurance plan shall enroll in that plan as a
