BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

5	shall be prohibited during a community event:		
6	(1) On public beaches and beach parks;		
7	(2) In public parks and recreational areas;		
8	(3) In other recreational areas designated as recreational		
9	by the state or county agency organizing or funding		
10	the community event; and		
11	(4) In areas within twenty feet of the nonsmoking area;		
12	provided that the nonsmoking area is within the site of the		
13	community event."		
14	SECTION 2. Section 328J-1, Hawaii Revised Statutes, is		
15	amended by adding a new definition to be appropriately inserted		
16	and to read as follows:		
17	"Community event" means any function of over twenty-five		
18	people organized by a state or county agency or fully or

3	SECT	TION 3. Section 328J-7, Hawaii Revised Statutes, is
4	amended t	o read as follows:
5	"[+]	§328J-7[] Exceptions. Notwithstanding any other
6	provision	of this chapter to the contrary, the following areas
7	shall be	exempt from the provisions of sections 328J-3, 328J-4,
8	and 328J-	5:
9	(1)	Private residences, except when used as a licensed
10		child care, adult day care, or health care facility;
11	(2)	Hotel and motel rooms that are rented to guests and
12		are designated as smoking rooms; provided that not
13		more than twenty per cent of rooms rented to guests in
14		a hotel or motel may be so designated. All smoking
15		rooms on the same floor shall be contiguous and smoke
16		from these rooms shall not infiltrate into areas where
17		smoking is prohibited under this chapter. The status
18		of rooms as smoking or nonsmoking may not be changed,
19		except to add additional nonsmoking rooms;
20	(3)	Retail tobacco stores; provided that smoke from these
21		places shall not infiltrate into areas where smoking

is prohibited under this chapter;
