A BILL FOR AN ACT

RELATING TO THE HAWAII TOBACCO SETTLEMENT SPECIAL FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the State is 2 undergoing a significant and possibly protracted economic 3 downturn in tandem with the national and global economic and financial crises. Numerous jobs have been lost, a number of 4 large and small companies have declared bankruptcy or left the 5 6 State, and many families have suffered foreclosure on their over-mortgaged houses. In the past year, the council on 7 revenues has consistently reduced its forecasts of Hawaii's tax 8 revenues. Across-the-board spending restrictions have already 9 10 been put in place in state government and a general hiring freeze has already been implemented except in areas that impact 11 12 public health and safety.

In the face of these extraordinary conditions, the State cannot proceed with business as usual. All resources must be examined to address critical statewide health, safety, and educational needs.

(2)9 SECTION 4. Section 328L-4, Hawaii Revised Statutes, is 10 amended to read as follows: 11 "[{]§328L-4[]] Use of funds appropriated to the department. healthy lifestyles (including fitness, nutrition, and 1 2 tobacco control), and prevention oriented public 3 health programs.

For purposes of paragraph (2), the director shall convene 4 an advisory group that shall be separate from the tobacco 5 prevention and control advisory board, to strategically plan the 6 development and implementation of preventive systems to achieve 7 measurable outcomes and to make recommendations for the 8 9 expenditure of these moneys. The advisory group shall be 10 composed of nine members with expertise in the programs under paragraph (2), and shall be selected at the discretion of the 11 12 director."

13 SECTION 5. Statutory material to be repealed is bracketed 14 and stricken. New statutory material is underscored.

15 SECTION 6. This Act shall take effect upon its approval and be repealed on June 30, 2015; provided that the amendments 16 made to section 328L-2(b), Hawaii Revised Statutes, by section 2 17 18 of this Act, shall not be repealed when that section is repealed 19 and reenacted on June 30, 2011, pursuant to Act 16, Session Laws 20 of Hawaii 2008.
