A BILL FOR AN ACT

RELATING TO AUTOMATED EXTERNAL DEFIBRILLATORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 The legislature finds that more than two SECTION 1. 2 hundred fifty thousand Americans die from sudden cardiac arrest 3 each year. The legislature further finds that eighty per cent 4 of cardiac arrests occur at home, at a workplace, or at 5 locations that people normally frequent, such as schools. 6 According to the Sudden Cardiac Arrest Association, a victim's 7 rate of survival is ninety per cent if defibrillation is 8 provided within the first minute following cardiac arrest, and 9 the rate of survival decreases by approximately ten per cent
- 10 every minute thereafter. Thirty to fifty per cent of victims
- 11 will likely survive if cardiopulmonary resuscitation and an
- 12 automated external defibrillator are used within five minutes of
- 13 collapse.
- 14 The purpose of this Act is to improve the safety of
- 15 students, faculty, staff, and visitors at Hawaii's schools by
- 16 requiring all public and private elementary schools, middle
- 17 schools, high schools, the University of Hawaii and community

6 SECTION 3. This Act shall take effect upon its approval.
