### A BILL FOR AN ACT

RELATING TO HIGHWAY SAFETY.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 286-107, Hawaii Revised Statutes, is 2 amended by amending subsections (b) and (c) to read as follows: "(b) Except as otherwise provided in subsection (c), an 3 4 applicant for a renewal of a driver's license under this 5 section, or the reactivation of an expired license under section 6 286-107.5(a), shall appear in person before the examiner of 7 drivers and the examiner of drivers shall administer such 8 physical examinations as the state director of transportation 9 deems necessary to determine the applicant's fitness to continue 10 to operate a motor vehicle [-]; provided that for an applicant 11 who is eighty-five years of age or older at the time of renewal 12 or reactivation, the examination shall include the actual 13 demonstration of ability to exercise ordinary and reasonable 14 control in the operation of a motor vehicle. 15 (c) Any person who holds a category (1), (2), or (3) 16 license issued under this part who is unable to appear in person before the examiner of drivers to apply for a renewal of the **17** 18 driver's license, may[, if the person is not disqualified from HB LRB 10-0335

renewing the license under subsection (a) except as provided 1 2 under subsection (h), apply for a renewal by mail. ] apply for 3 renewal by mail; provided that the person is not disqualified 4 from renewing the license under subsection (a); provided further 5 that the person is not eighty-five years of age or older at the 6 time of renewal. The applicant's request to have the license 7 renewed by mail must be received by the examiner of drivers 8 within ninety days after the expiration of the license or it 9 shall be treated as an application for reactivation of an 10 expired license under section 286-107.5. The examiner of 11 drivers [shall], upon receipt of the request, shall furnish the 12 applicant with all necessary forms and instructions. An 13 application for renewal made pursuant to this subsection shall 14 be accompanied by a statement from a licensed physician 15 certifying that the applicant was examined by the licensed 16 physician not more than six months prior to the expiration date 17 of the applicant's license and that the applicant was found by 18 [such] the examination to have met the physical requirements 19 established by the state director of transportation for the 20 renewal of licenses. The application for renewal shall also be 21 accompanied by:

1	(1)	A notarized statement of the applicant certifying that

11	SECTION 2. Section 286-107.5, Hawaii Revised Statutes, is	
12	amended by amending the title and subsection (a) to read as	
13	follows:	
14	"[+]\$286-107.5[+] Reactivation of expired license; fees;	
15	road test waived. (a) Unless revoked or suspended, and except	
16	as provided in subsection (b), all drivers' licenses expired	
17	under section 286-106 may be reactivated by the licensee in	
18	accordance with the requirements and procedures set forth for	
19	the renewal of licenses under section 286-107(b). No person	
20	seeking reactivation of an expired license under this subsection	
21	shall be required to undergo reexamination of the person's	
22	driving skills under section 286-108[-], except as provided

- 1 under section 286-107 (b) for persons who are eighty-five years
- 2 of age or older. The examiner of drivers shall require the
- 3 holder of an expired license to pay a reactivation fee of \$5 for
- 4 each thirty-day period, or fraction thereof, that has elapsed
- 5 after the ninety-day grace period."
- 6 SECTION 3. Statutory material to be repealed is bracketed
- 7 and stricken. New statutory material is underscored.
- 8 SECTION 4. This Act shall take effect upon its approval.
