BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 26-17, Hawaii Revised Statutes, is
 amended to read as follows:

3 "§26-17 Department of Hawaiian home lands. (a) The
4 department of Hawaiian home lands shall be headed by an
5 executive board to be known as the Hawaiian homes commission.

6 (b) The commission shall be composed of nine members. The 7 appointment, tenure, and removal of the members and the filling 8 of vacancies on the commission shall be in accordance with 9 section 26-34 and section 202(a) of the Hawaiian Homes 10 Commission Act of 1920, as amended. The governor shall appoint 11 the chairperson of the commission from among the members 12 thereof.

13 (c) The commission may delegate to the chairperson such 14 duties, powers, and authority, or so much thereof as may be 15 lawful or proper, for the performance of the functions vested in 16 the commission.
