 all documents considered at the review, including the
 arrest report and the sworn statements of law
 enforcement officers or other persons, prior to the

10 SECTION 2. Section 291E-39, Hawaii Revised Statutes, is

12 "§291E-39 Fees and costs. The director may assess and 13 collect a [\$30] \$50 fee from the respondent to cover the costs 14 of processing the respondent's request for an administrative 15 hearing. These costs include but shall not be limited to: the 16 cost of photocopying documents; conditional license permits, 17 temporary permits, temporary motor vehicle registrations, 18 temporary number plates, and relicensing forms; interpreter 19 services; and other similar costs; provided that the costs of 20 issuing subpoenas for witnesses, including mileage fees, shall 21 be borne by the party requesting the subpoena.
