A BILL FOR AN ACT

RELATING TO HAWAIIAN ARTIFACTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 6E-2, Hawaii Revised Statutes, is
- 2 amended by adding a new definition to be appropriately inserted
- 3 and to read as follows:
- 4 ""Hawaiian artifacts" means objects or materials associated
- 5 with the culture, history, or heritage of the aboriginal peoples
- 6 inhabiting the Hawaiian Islands which exercised sovereignty and
- 7 subsisted in the Hawaiian Islands in 1778, and which peoples
- 8 thereafter continued to reside in Hawaii."
- 9 SECTION 2. Section 6E-7, Hawaii Revised Statutes, is
- 10 amended to read as follows:
- 11 "§6E-7 State title to historic property. (a) All
- 12 historic property located on lands or under waters owned or
- 13 controlled by the State shall be the property of the State. The
- 14 control and management of the historic property shall be vested
- 15 in the department.
- 16 (b) The department may dispose of the historic property
- 17 subject to chapter 171 and subject further to those
- 18 reservations, restrictions, covenants, or conditions which HB LRB 10-0997.doc

- 1 relate to the preservation of the historic property, such as
- 2 rights of access, public visitation, operation, maintenance,
- 3 restoration, and repair. The department shall determine the
- 4 conditions for any research affecting the historic property and
- 5 may issue permits for the research.
- 6 (c) The State shall hold known burial sites located on
- 7 lands or under waters owned or controlled by the State in trust
- 8 for preservation or proper disposition by the lineal or cultural
- 9 descendants.
- 10 (d) The State shall not transfer any historic property or
- 11 aviation artifact under its jurisdiction without the concurrence
- 12 of the department, and shall not transfer any burial site under
- 13 its jurisdiction without consulting the appropriate island
- 14 burial council.
- 15 (e) The State shall hold Hawaiian artifacts found on lands
- 16 or under waters owned or controlled by the State in trust for
- 17 preservation or proper disposition."
- 18 SECTION 3. New statutory material is underscored.
