A BILL FOR AN ACT

RELATING TO THE EMPLOYEES' RETIREMENT SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the counties need 2 representation on the board of trustees of the employees' 3 retirement system of the State. The counties contribute a 4 considerable share to retirement system costs, and their 5 employees and retirees are a significant portion of the system's 6 membership. County representation will ensure that the board possesses expertise about county finances and the county 7 8 workforce in making benefit decisions. Lack of representation may result in a situation where board members do not fully 9 10 consider the costs of their actions on the counties, resulting 11 in changes that may not be cost beneficial in the aggregate or 12 may affect the retirement income of county employees and 13 retirees.

14 The purpose of this Act is to include county representation 15 on the membership of the board of trustees of the employees' 16 retirement system.

SECTION 2. Section 88-24, Hawaii Revised Statutes, isamended to read as follows:

1	the terms to expire January 1 of each odd-numbered

3	(4) One member appointed by the Hawaii council of mayors	
4	to represent the counties, to serve for a term of six	
5	years with each term to expire on January 1 of an odd-

7	Each trustee shall serve until the trustee's successor is	
8	elected or appointed, as the case may be, and qualified. For	
9	the purpose of this section, the term "general employees"	
10	includes police officers and firefighters."	
11	SECTION 3. Statutory material to be repealed is bracketed	
12	and stricken. New statutory material is underscored.	
13	SECTION 4. This Act shall take effect upon its approval.
