## A BILL FOR AN ACT

RELATING TO PHARMACIST LICENSURE.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

| 1  | SECTION 1. The University of Hawaii at Hilo college of           |

| 2  | pharmacy accepted its first class in the fall of 2007, and is    |
| 3  | the only accredited pharmacy school in Hawaii and the Pacific    |
| 4  | Basin. For decades, Hawaii has been viewed as the crossroads of  |
| 5  | the Pacific, merging cultures and people from all walks of life. |
| 6  | Students from Hawaii, other states, the United States            |
| 7  | territories and possessions, and even other countries, come to   |
| 8  | study at the University of Hawaii at Hilo college of pharmacy,   |
| 9  | which currently is on track for full accreditation in 2011 when  |
| 10 | its first class of pharmacy students will graduate.              |
| 11 | In order to graduate from the college of pharmacy, students      |
| 12 | must participate in advanced pharmacy practice experiences in    |
| 13 | their fourth and final year. The advanced pharmacy practice      |
| 14 | experiences begin in the summer after the third year of pharmacy |
| 15 | school and includes a minimum of 1,440 hours of practical        |
| 16 | experience. Students participate in six different types of       |
| 17 | rotations. Mandatory rotations include a hospital or health      |

system pharmacy, an inpatient/acute care facility, an ambulatory

1 care clinic, and a community pharmacy. Students may take an 2 additional two electives to fulfill the experience requirements. 3 The first class of the University of Hawaii at Hilo college 4 of pharmacy will begin its advanced pharmacy practice experience 5 rotations in May of 2010. Students will perform their rotations 6 in the traditional pharmacy setting as well as in other 7 designated advanced practice locations under the supervision of 8 a registered pharmacist where the practice of pharmacy occurs. 9 Geographically, the rotations will occur in Hawaii and other 10 states, the District of Columbia, and the United States 11 territories. **12** Section 461-5, Hawaii Revised Statutes, currently allows 13 only the hours of practical experience performed in a pharmacy 14 in one of the fifty states to count toward the 1,500 hours of practical experience required for licensure as a pharmacist. As 15 16 such, students who perform their rotations outside of the **17** traditional pharmacy setting will not receive credit that counts 18 toward their licensure requirements, even though those students 19 are engaged in the practice of pharmacy under the supervision of 20 a registered pharmacist at other designated advanced practice 21 locations, such as clinics and acute care facilities. Moreover, 22 advanced pharmacy practice experience rotations performed in one

- 1 of the United States territories or the District of Columbia
- 2 will not count toward licensure requirements.
- 3 Therefore, the purpose of this Act is to ensure that
- 4 advanced pharmacy practice experience rotations performed in a
- 5 United States territory or the District of Columbia or at a
- 6 designated advanced practice location under the supervision of a
- 7 registered pharmacist will also count toward pharmacist
- 8 licensure requirements.
- 9 SECTION 2. Section 461-1, Hawaii Revised Statutes, is
- 10 amended by adding a new definition to be appropriately inserted
- 11 and to read as follows:
- ""Territory" means Puerto Rico, the Northern Mariana
- 13 Islands, the Virgin Islands, Guam, or American Samoa."
- 14 SECTION 3. Section 461-5, Hawaii Revised Statutes, is
- 15 amended by amending subsection (a) to read as follows:
- 16 "(a) Any applicant for a license as a pharmacist shall
- 17 submit an application on a form prescribed by the board and
- 18 shall provide evidence to the board that the applicant:
- 19 (1) Is at least eighteen years of age;
- 20 (2) Holds a degree from a school or college of pharmacy or
- 21 department in a university which is recognized and
