A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Chapter 132C, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	" <u>§132C-</u> Reduced ignition propensity cigarette program
5	special fund. (a) There is established a reduced ignition
6	propensity cigarette program special fund into which shall be
7	deposited the moneys collected pursuant to section 132C-4.
8	All interest earned or accrued on moneys deposited in the fund
9	shall become part of the fund. The fund shall be administered
10	by the state fire council.
11	(b) Subject to legislative authorization, the state fire
12	council may expend moneys from the fund to defray the actual
13	cost of activities and requirements provided in subsections 132-
14	16(c) and 132C-4(a); provided that all unencumbered and
15	unexpended moneys in excess of \$ remaining on balance
16	in the reduced ignition propensity cigarette program special
17	fund at the close of June 30 of each year shall lapse to the
18	credit of the state general fund."

9	"(a) Each manufacturer shall submit to the state fire
10	council written certification attesting that each cigarette has
11	been tested in accordance with, and has met the performance
12	standard required under section 132C-3. The description of each
13	cigarette listed in the certification shall include:
14	(1) The brand or trade name on the package;
15	(2) Style, such as light or ultra light;
16	(3) Length in millimeters;
17	(4) Circumference in millimeters;
18	(5) Flavor, such as menthol, if applicable;
19	(6) Filter or nonfilter;
20	(7) Package description, such as a soft pack or box;
21	(8) The mark approved pursuant to subsection (b);

1	(9) The name, address, and telephone number of the
2	laboratory, if different than the manufacturer that
3	conducted the test; and
4	(10) The date that the testing occurred.
5	Each cigarette certified under this subsection shall be
6	recertified every three years. For each cigarette listed in a
7	certification, a manufacturer shall pay to the state fire
8	council a \$375 fee. The state fire council is authorized to
9	annually adjust this fee to ensure it defrays the actual costs
10	of the administration, processing, testing, enforcement,
11	inspection, staffing requirements, and oversight activities
12	required by this chapter.
13	The certifications shall be made available to the attorney
14	general for purposes consistent with this chapter."
15	SECTION 4. There is appropriated out of the general
16	revenues of the State of Hawaii the sum of \$ or so
17	much thereof as may be necessary for fiscal year 2010-2011 to be
18	deposited into the reduced ignition propensity cigarette program
19	special fund created in section 1 of this Act.
20	SECTION 5. There is appropriated out of the reduced
21	ignition propensity cigarette program special fund the sum of
