A BILL FOR AN ACT

RELATING TO PUBLIC SAFETY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Chapter 132C, Hawaii Revised Statutes, is 2 amended by adding a new section to be appropriately designated 3 and to read as follows: 4 "§132C- Reduced ignition propensity cigarette program 5 **special fund.** (a) There is established a reduced ignition 6 propensity cigarette program special fund into which shall be 7 deposited the moneys collected pursuant to section 132C-4. 8 All interest earned or accrued on moneys deposited in the fund 9 shall become part of the fund. The fund shall be administered 10 by the state fire council. 11 (b) Subject to legislative authorization, the state fire 12 council may expend moneys from the fund to defray the actual 13 cost of activities and requirements provided in sections 132-14 16(c) and 132C-4(a); provided that all unencumbered and 15 unexpended moneys in excess of \$ remaining on balance 16 in the reduced ignition propensity cigarette program special 17 fund at the close of June 30 of each year shall lapse to the 18 credit of the state general fund."
