A BILL FOR AN ACT

RELATING TO LEGISLATIVE CAUCUSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. For many years, the Hawaii state legislature
- 2 has had a keiki caucus and kupuna caucus, each composed of
- 3 members from both the senate and house of representatives. The
- 4 keiki caucus, established in 1994, concentrates on issues
- 5 concerning the betterment of the lives of children and youth.
- 6 The kupuna caucus, established in January 2005, concentrates on
- 7 issues concerning the betterment of lives of elders and
- 8 grandparents, including aging, long-term care, and elder abuse.
- 9 The keiki caucus and the kupuna caucus each hold
- 10 informational legislative meetings and briefings in the interim
- 11 to gather information from community groups, from the public in
- 12 general, and from affected individuals in particular.
- 13 Government agencies also participate in the meetings and
- 14 briefings. Oftentimes, issues can be resolved at a meeting or
- 15 briefing by raising public awareness about the problem and
- 16 encouraging dialogue among the parties. The legislature finds
- 17 that the keiki caucus and kupuna caucus perform an integral

- 1 function of the legislative process of information gathering,
- 2 problem solving, and making recommendations for change, hearing
- 3 the voices of people who may not otherwise be heard.
- 4 The purpose of this Act is to establish the keiki caucus
- 5 and the kupuna caucus in statute.
- 6 SECTION 2. The Hawaii Revised Statutes, is amended by
- 7 adding a new chapter to be appropriately designated and to read
- 8 as follows:
- 9 "CHAPTER
- 10 LEGISLATIVE CAUCUSES
- 11 § -1 Keiki caucus; kupuna caucus; established. (a)
- 12 There is established a joint legislative keiki caucus to address
- 13 issues concerning the well-being, health, safety, and welfare of
- 14 children and youth.
- 15 (b) There is established a joint legislative kupuna caucus
- 16 to address issues concerning the aged and elderly.
- 17 (c) Membership of the joint legislative keiki caucus and
- 18 the joint legislative kupuna caucus shall consist of members of
- 19 both houses of the legislature. The legislative members of the
- 20 caucuses may also decide to include representatives of youth-
- 21 serving and elderly-serving organizations and individuals from

- 1 the community as members of the caucus with regard to any
- 2 particular issue under consideration by the caucus."
- 3 SECTION 3. This Act shall take effect on January 1, 2050.
