#### A BILL FOR AN ACT

RELATING TO PERSONAL HOME CARE ASSISTANTS.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. Section 321-14.8, Hawaii Revised Statutes, is
2	amended to read as follows:
3	"[+]§321-14.8[+] Home care agencies; licensing.
4	(a) Beginning July 1, 2010, each home care agency shall be
5	licensed by the department of health to ensure the health,
6	safety, and welfare of clients.
7	[ <del>(b) The department of health shall adopt rules in</del>
8	accordance-with-chapter 91-to:
9	(1) Protect the health, safety, and civil rights of
10	elients of home care agencies; and
11	(2) Provide for the licensure of home care agencies
12	(c) A service provider agency under contract for services
13	with the city and county of Honolulu elderly affairs division
14	shall be exempt from the licensing requirement of this
15	[section.] subsection.
16	(b) Except as otherwise provided by this section, no home
17	care agency shall employ or contract with any individual as a
18	personal home care assistant for more than four months. on a



1	full-time, temporary, per diem, or other basis, unless the
2	individual has completed home care agency based personal care
3	training in the care required by the client and supervised by a
4	registered nurse. The home care agency shall document the
5	training received by the personal home care assistant in the
6	personal home care assistant's personnel file.
7	(c) A home care agency shall develop a written training
8	plan for services to be provided to a client that is approved by
9	the home care agency coordinator. The training plan shall
10	<u>include:</u>
11	(1) Observation, reporting, and documentation of client
12	status and the care or services furnished;
13	(2) Maintenance of a clean, safe, and healthy environment;
14	(3) Recognition of emergencies and necessary emergency
15	<pre>procedures;</pre>
16	(4) Safe bathing techniques;
17	(5) Assistance in toileting;
18	(6) Safe transfer techniques and ambulation;
19	(7) Assistance with feeding and fluid intake; and
20	(8) Client rights and responsibilities and the need for
21	respect for the client and for the privacy and
22	property of the client.

1	(d) No personal home care assistant shall provide personal
2	care services to a client until the personal home care assistant
3	has been oriented to the needs of the client and has
4	demonstrated to the registered nurse supervisor, competency in
5	the skills required by the training plan.
6	(e) Supervisory visits shall be made according to the
7	client need, as determined by the nursing supervisor, at least
8	once every six months.
9	(f) If a survey by the department of health determines
10	that a deficiency in personal care services is attributable to
11	insufficient personal home care assistant skill or training, the
12	department of health may require changes in the provisions of
13	the training plan related to the deficient skill.
14	(g) No personal home care assistant shall provide services
15	to a client until a criminal history background check is
16	performed in accordance with section 321-15.2.
17	(h) The department of health shall adopt rules in
18	accordance with chapter 91 to:
19	(1) Protect the health, safety, and civil rights of
20	clients of home care agencies;

(2) Provide for the licensure of home care agencies; and

1	(3) Provide changes in the provisions of a training plan
2	related to a deficient skill if a survey by the
3	department of health determines that a deficiency is
4	attributable to insufficient personal home care
5	assistant skill or training.
6	[ <del>(d)</del> ] <u>(i)</u> For purposes of this section:
7	"Home care agency" means a public or proprietary agency, a
8	private, nonprofit organization, or a subdivision of an agency
9	or organization, engaged in providing home care services to
10	clients in the client's residence. The term "home care agency"
11	does not apply to an individual, including an individual who is
12	incorporated as a business, or is an unpaid or stipended
13	volunteer.
14	"Home care agency coordinator" means a licensed practical
15	nurse who is responsible and accountable for the functioning of
16	the home care agency and the services provided.
17	"Home care services" include but are not limited to:
18	(1) Personal care, including assistance with dressing,
19	feeding, and personal hygiene to facilitate self-care;
20	(2) Homemaker assistance, including housekeeping,
21	shopping, and meal planning and preparation; and

1 (3) Respite care and assistance and support provided to 2 the family. 3 "Home health aide" means a person who has successfully 4 completed the basic prescribed nurse aide course in the 5 community college system, or an equivalent course, with 6 additional training and supervision to prepare the person for 7 this role. "Personal home care assistant" means an individual employed 8 9 by a home care agency, who provides nonmedical personal care to 10 clients in their temporary or permanent place of residence for a 11 fee, and regardless of whether the individual is a home health 12 aide." 13 SECTION 2. Section 321-15.2, Hawaii Revised Statutes, is 14 amended by amending subsection (a) to read as follows: 15 "(a) For the purposes of this section: 16 "Adults" means individuals aged eighteen years or older. 17 "Applicant" means a person or entity seeking licensure to operate a healthcare facility. If the applicant is an entity, 18 19 the term "applicant" shall also include its principals, 20 directors, partners, managers, agents, and representatives to

the extent that any of these individuals will have access to or

- 1 contact with clients, their finances, assets, personal property,
- 2 medical records, or individually identifiable information.
- 3 "Conviction for a relevant crime" means any federal or
- 4 state conviction for any relevant crime as defined in this
- 5 section.
- 6 "Criminal history record name inquiry" means a record check
- 7 by name for any federal or state conviction for any relevant
- 8 crime as defined in this section.
- 9 "Department" means the department of health.
- 10 "Direct patient access employee" means any individual,
- 11 including a volunteer, who has access to a patient or resident
- 12 of a healthcare facility, or any provider through employment or
- 13 through an agreement or contract with such a facility or
- 14 provider. Such individuals include but are not limited to:
- 15 physicians, nurses, nursing assistants, home health aides,
- 16 personal home care assistants, therapists, activities personnel,
- 17 and support staff (i.e., housekeeping, dietary, etc.) who have
- 18 direct access to patients or patient belongings.
- 19 "Disqualifying information" means a conviction for a
- 20 relevant crime or a finding of patient or resident abuse.
- 21 "Healthcare facility" means a facility or setting where a
- 22 frail, elderly, or disabled adult receives care or is provided



- 1 living accommodations such as a skilled nursing facility,
- 2 intermediate care facility, adult residential care home,
- 3 expanded adult residential care home, assisted living facility,
- 4 home health agency, home care agency, hospice, adult day health
- 5 center, special treatment facility, therapeutic living program,
- 6 intermediate care facility for the mentally retarded, hospital,
- 7 rural health center, and rehabilitation agency.
- 8 "Home care agency" has the same meaning provided in section
- 9 321-14.8.
- 10 "Name inquiry" means a criminal history record check
- 11 conducted by using the name and other identifying information of
- 12 the individual, in lieu of a fingerprint check.
- "Operator" means an individual or entity that is licensed
- 14 or is seeking licensure to operate a healthcare facility and is
- 15 responsible for the management and overall operations of that
- 16 healthcare facility.
- "Personal home care assistant" has the same meaning
- 18 provided in section 321-14.8.
- "Relevant crime" means:
- 20 (1) Any offense described in 42 United States Code

- 22 Social Security Act); or

1 (2) A crime of such a serious nature or circumstance that 2 the department finds its perpetrator to pose a risk to 3 the health, safety, or well-being of a patient or 4 resident.
