#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 Section 11-205.5, Hawaii Revised Statutes, is SECTION 1. 2 amended by amending subsections (a) and (b) to read as follows: 3 "(a) It shall be unlawful for the person exempt from 4 competitive solicitation pursuant to chapters 102, 103, 103D, 5 and 103F, who enters into any contract with the State, any of 6 its counties, or any department or agency thereof either for the 7 rendition of personal services, the buying of property, or 8 furnishing any material, supplies, or equipment to the State, 9 any of its counties, department or agency thereof, or for 10 selling any land or building to the State, any of its counties, 11 or any department or agency thereof, if payment for the 12 performance of the contract or payment for material, supplies, 13 equipment, land, property, or building is to be made in whole or 14 in part from funds appropriated by the legislative body, at any 15 time between the execution of the contract through the 16 completion of the contract, to:
