# H.B. NO. 2279

### A BILL FOR AN ACT

RELATING TO THE DEPOSIT BEVERAGE CONTAINER PROGRAM.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the deposit beverage 2 container program does not provide for the redemption and recycling of plastic bottle tops and caps from deposit beverage 3 4 containers. Some redemption centers accept and dispose of 5 plastic bottle tops and caps from redeemers who offer deposit beverage containers for redemption. However, other redemption 6 centers do not accept the caps, and redeemers often dispose of 7 8 their bottle tops and caps improperly, resulting in increased 9 litter in the State.

10 The purpose of this Act is to require all redemption 11 centers to accept and properly dispose of bottle tops and caps 12 from redeemed deposit beverage containers and thereby reduce 13 litter in the State.

SECTION 2. Section 342G-114, Hawaii Revised Statutes, isamended by amending subsection (d) to read as follows:

16 "(d) Redemption centers shall:

17 (1) Accept all types of empty deposit beverage containers
18 for which a deposit has been paid;

1	(2)	Verify that all containers to be redeemed bear a valid
2		Hawaii refund value;
3	(3)	Pay to the redeemer the full refund value in either
4		cash or a redeemable voucher for all deposit beverage
5		containers, except as provided in section 342G-116;
6	(4)	Ensure each deposit beverage container collected is
7		recycled through a contractual agreement with an out-
8		of-state recycler or an in-state recycling facility
9		permitted by the department; provided that this
10		paragraph shall not apply if the redemption center is
11		operated by a recycler permitted by the department;
12	(5)	Remain open at least thirty hours per week in high
13		density population areas, of which at least five hours
14		shall be on Saturday or Sunday; [ <del>and</del> ]
15	(6)	Forward the documentation necessary to support claims
16		for payment as stated in section $342G-119[-;]$ and
17	(7)	When offered by a redeemer, accept and properly
18		dispose of bottle tops and caps from redeemed deposit
19		beverage containers; provided that redemption centers
20		may require that the bottle tops and caps be removed
21		from the containers."
