A BILL FOR AN ACT

RELATING TO FARM PRODUCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The purpose of this Act is to establish the 2 farm produce dealers special fund under the department of 3 agriculture. SECTION 2. Chapter 145, Hawaii Revised Statutes, is 4 5 amended by adding a new section to part I to be appropriately designated and to read as follows: 6 7 "§145-Farm produce dealers special fund. (a) There is established within the state treasury the farm produce 8 9 dealers special fund. The following moneys shall be deposited into the farm 10 11 produce dealers special fund: 12 Fees, charges, expenses, and other moneys collected (1)13 under this part; 14 (2) Fines collected from violations of this part; and 15 (3) Interest earned on the moneys in the special fund. 16 (c) The moneys in the special fund shall be expended for the licensure of commission merchants, dealers, brokers, agents, 17
