## A BILL FOR AN ACT

RELATING TO VIOLENCE AGAINST HEALTH CARE PERSONNEL.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 707-711, Hawaii Revised Statutes, is
2	amended b	y amending subsection (1) to read as follows:
3	"(1)	A person commits the offense of assault in the second
4	degree if	:
5	(a)	The person intentionally or knowingly causes
6		substantial bodily injury to another;
7	(b)	The person recklessly causes serious or substantial
8		bodily injury to another;
9	(c)	The person intentionally or knowingly causes bodily
10		injury to a correctional worker, as defined in section
11		710-1031(2), who is engaged in the performance of duty
12		or who is within a correctional facility;
13	(d)	The person intentionally or knowingly causes bodily
14		injury to another with a dangerous instrument;
15	(e)	The person intentionally or knowingly causes bodily
16		injury to an educational worker who is engaged in the
17		performance of duty or who is within an educational
18		facility. For the purposes of this paragraph,

	"educational worker" means: any administrator,
	specialist, counselor, teacher, or employee of the
	department of education or an employee of a charter
	school; a person who is a volunteer, as defined in
	section 90-1, in a school program, activity, or
	function that is established, sanctioned, or approved
	by the department of education; or a person hired by
	the department of education on a contractual basis and
	engaged in carrying out an educational function;
(f)	The person intentionally or knowingly causes bodily
	injury to any emergency medical services [personnel]
	provider who is engaged in the performance of duty.
	For the purposes of this paragraph, "emergency medical
	services [personnel" shall have the same meaning as in
	section 321-222;] provider" means emergency medical
	services personnel, as defined in section 321-222, and
	a physician, physician's assistant, nurse, or nurse
	practitioner who provides medical services in the
	emergency room of a hospital; or
(g)	The person intentionally or knowingly causes bodily
	injury to a person employed at a state-operated or
	-contracted mental health facility. For the purposes

1		of this paragraph, "a person employed at a state-
2		operated or -contracted mental health facility"
3		includes health care professionals as defined in
4		section 451D-2, administrators, orderlies, security
5		personnel, volunteers, and any other person who is
6		engaged in the performance of a duty at a state-

8	SECT	ION 2. Section 707-716, Hawaii Revised Statutes, is
9	amended by	y amending subsection (1) to read as follows:
10	"(1)	A person commits the offense of terroristic
11	threateni	ng in the first degree if the person commits
12	terrorist	ic threatening:
13	(a)	By threatening another person on more than one
14		occasion for the same or a similar purpose;
15	(b)	By threats made in a common scheme against different
16		persons;
17	(c)	Against a public servant arising out of the
18		performance of the public servant's official duties.
19		For the purposes of this paragraph, "public servant"
20		includes but is not limited to an educational worker
21		"Educational worker" has the same meaning as defined
22		in section 707-711;
