A BILL FOR AN ACT

PROPOSING AMENDMENTS TO THE HAWAII CONSTITUTION RELATING TO THE BOARD OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII: 1 SECTION 1. Article X, section 2, of the Hawaii 2 Constitution is amended to read as follows: 3 "BOARD OF EDUCATION 4 Section 2. There shall be a board of education [composed 5 of members who shall be elected in a nonpartisan manner by 6 qualified voters, as provided by law, from two at large school board districts. The first school board district shall be 7 · 8 comprised of the island of Oahu and all other islands not 9 specifically enumerated. The second school board district shall 10 be comprised of the islands of Hawaii, Maui, Lanai, Molokai, 11 Kahoolawe, Kauai and Niihau. Each at large school board 12 district shall be divided into departmental school districts, as 13 may be provided by law. There shall be at least one member 14 residing in each departmental school district. The Hawaii State 15 Student Council shall select a public high school student to 16 serve as a nonvoting member on the board of education.] whose 17 voting members shall be appointed by the governor, with the
