## A BILL FOR AN ACT

RELATING TO PROCUREMENT.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I			
2	SECTION 1. The legislature finds that in this period of			
3	high economic turmoil, procedural changes are necessary to			
4	enable the State to achieve a quick recovery and to provide			
5	effective economic stimulation. The legislature further find			
6	that Hawaii's public procurement process is inefficient and			
7	antiquated. Procedures require protracted periods of time			
8	between each procurement step. Currently, the awarding of a			
9	contract is subject to prolonged review, thereby preventing			
10	government projects from proceeding in a timely manner.			
11	Senate Concurrent Resolution No. 132, S.D. 1, regular			
12	session of 2009, established a task force to determine the			
13	economic contributions of the construction industry in Hawaii.			
14	As directed in the concurrent resolution, the task force has			
15	developed a series of proposals for state actions to preserve			
16	and create new jobs in the local construction industry. This			
17	part implements one of the task force's proposals			

1	Accordingly, the purpose of this part is to amend			
2	chapter 103D, Hawaii Revised Statutes, to require certain state			
3	and county agencies to award public contracts on bid proposals			
4	within thirty days of the bid opening date. In doing so,			
5	however, it is also the purpose of this part to strike a balance			
6	between expedited procedures and necessary accountability and			
7	transparency.			
8	SECTION 2. Chapter 103D, Hawaii Revised Statutes, is			
9	amended by adding a new section to be appropriately designated			
10	and to read as follows:			
11	"§103D- Contract award deadlines. Notwithstanding any			
12	other statute or administrative rule relating to procurement,			
13	contracts for projects of the department of Hawaiian home lands			
14	and department of transportation that are awarded after bidding			
15	shall be awarded within thirty days of the bid opening date;			
16	<pre>provided that:</pre>			
17	(1) An extension, not exceeding 14 business days, shall be			
18	permitted if it will provide the opportunity for			
19	further negotiations with the lowest responsible			
20	bidder relating to considerations that could result in			
21	benefits to the public;			

1	(2)	Contracts for design professional services furnished		
2		by persons licensed under chapter 464 shall be awarded		
3		within forty-five days of the bid opening date;		
4	(3)	The award deadline shall not apply if the lowest		
5		responsible bid exceeds available funding; and		
6	(4)	The award deadline shall not apply to design-build		
7		contracts.		
8	For	the purposes of this subsection "design-build" means		
9	the combi	ning of design and construction into a single request		
10	for propo	sal."		
11		PART II		
12	SECTION 3. Chapter 103D, Hawaii Revised Statutes, is			
13	amended by adding a new section to be appropriately designated			
14	and to read as follows:			
15	"§103D- Gifts to the State not procurement contracts.			
16	gift to the State shall not be deemed to constitute a			
17	procurement contract and shall not require a procurement			
18	contract to be accepted by the State as a gift; provided that			
19	the agency accepting a gift shall promptly report the gift to			
20	the state procurement office.

For purposes of this section, "gift" refers to donations of
material, labor, equipment, or other appropriate subjects of
donation."

SECTION 4. New statutory material is underscored.

SECTION 5. This Act shall take effect on July 1, 2010, and

shall be repealed on June 30, 2012.

## Report Title:

Procurement; 30-Day Contract Award Deadline; Gifts to the State

## Description:

Requires contracts for DHHL and DOT projects to be awarded within 30 days of the bid opening date, subject to sufficient available funding and an extension for further negotiations to benefit the public. Requires DHHL and DOT contracts for design professional services to be awarded within 45 days of the bid opening date. Specifies that gifts made to the State shall not constitute or require a procurement contract. Sunsets on July 1, 2012. (HB2441 CD1)
