A BILL FOR AN ACT

RELATING TO INSURANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I
2	SECTION 1. Section 87A-16, Hawaii Revised Statutes, is
3	amended to read as follows:
4	"[+] §87A-16[+] Health benefits plan; carriers. (a) The
5	board shall establish the health benefits plan or plans, which
6	shall be exempt from the minimum group requirements of chapter
7	431.
8	(b) The board may contract for health benefits plans or
9	provide health benefits through a noninsured schedule of
10	benefits.
11	(c) Notwithstanding any law to the contrary, the board
12	shall during open enrollment and other enrollment periods offer
13	an employee-beneficiary or dependent-beneficiary eligible for
14	enrollment and currently enrolled in a health benefits plan
15	established under this section, coverage for prescription drug
16	benefits that is identical to the coverage provided under the
17	employee-beneficiary's or dependent-beneficiary's current plan.

1	"Coverage" means the benefits, costs, and requirements for			
2	patient access to medical products and services as enumerated in			
3	the written explanation of benefits document issued by the			
4	health carrier.			
5	"Identical" means the exact benefit as provided in the			
6	written explanation of benefits document issued by the health			
7	carrier.			
8	"Prescription drug benefits" means the prescription drug			
9	benefits as defined in the explanation of benefits document			
10	issued by the health insurance carrier that describes the cost,			
11	cost-sharing, and available medications, as well as any			
12	utilization management requirements that patients must meet in			
13	order to access the prescribed drug."

15	SECTION 2. The purpose of this part is to improve access			
16	to the full range of health care services to Medicaid and QUEST			
17	members, by ensuring that Medicaid and QUEST health plans have			
18	the flexibility to provide appropriate health services via			
19	technological means such as telehealth.			
20	SECTION 3. Chapter 346, Hawaii Revised Statutes, is			
21	amended by adding a new section to be appropriately designated			
22	and to read as follows:

3	(1)	The department's approval for a health plan under the

5		services using a telehealth service; or	
6	(2)	In-person visits to qualify any telehealth service for	
7		coverage under the department's Medicaid or QUEST

9	For the pu	proses of this section, "telehealth" means the use of	
10	telecommunications services, as defined in section 269-1,		
11	including but not limited to real-time video conferencing- based		
12	communicat	tion, secure interactive and non-interactive web-based	
13	communicat	tion, and secure asynchronous information exchange, to	
14	<u>transmit p</u>	patient medical information, including diagnostic-	
15	<u>quality di</u>	gital images and laboratory results for medical	
16	interpretation and diagnosis, for the purpose of delivering

18	separated by distance. A standard telephone contact, facsimile		
19	transmissi	on, or an email text, in combination or by itself,

1	SECTION 4. This Act does not affect rights and duties that
2	matured, penalties that were incurred, and proceedings that were
3	begun before its effective date.
4	SECTION 5. Statutory material to be repealed is bracketed
5	and stricken. New statutory material is underscored.
6	SECTION 6. This Act shall take effect on July 1, 2020;
7	provided that the provisions of section 87A-16(c), Hawaii
8	Revised Statutes, in section 1 of this Act shall retroactively
9	apply to prescription drug plans of employee-beneficiaries and
10	dependent-beneficiaries of the employer-union health benefits
11	trust fund enrolled in health plans as of the effective date of
12	this Act, who enrolled during the open enrollment periods ending
13	on:
14	(1) For active employees, December 7, 2009; and
15	(2) For retirees, November 30, 2009;
16	provided further that notwithstanding the close of these open
17	enrollment periods, these beneficiaries shall prior to be
18	offered the coverage for prescription drug benefits required
19	under section 87A-16(c), Hawaii Revised Statutes, in section 1
20	of this Act.

Health Insurance; Drug Coverage; EUTF; Telehealth; Medicaid; QUEST

Description:

HB2461 HD2 HMS 2010-2025

Requires EUTF health benefits plans to allow enrollees to continue the same prescription drug coverage for current enrollees, and applies this provision retroactively to the 2009 EUTF open enrollment period. Prohibits the Department of Human Services from requiring its approval for a Medicaid or QUEST health plan to deliver services through telehealth, and from requiring in-person health care visits to qualify telehealth services for coverage under these health plans. Effective July 1, 2020. (HB2461 HD2)
