A BILL FOR AN ACT

RELATING TO THE EMERGENCY AND BUDGET RESERVE FUND.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:


- 1 In 1999, the legislature established the SECTION 1. 2 emergency and budget reserve fund as a temporary supplemental 3 source of funding for the State of Hawaii in times of emergency, 4 economic downturn, or unforeseen reduction in revenues. As set forth in section 328L-3, Hawaii Revised Statutes, specific 5 6 purposes for the fund include the maintaining of levels of 7 programs determined to be essential to public health, safety, 8 welfare, and education. 9 The legislature finds that the national and global economic 10 crisis has caused significant economic problems in numerous 11 industries in the state, including the airline, cruise ship, 12 tourist, and construction industries. Mass layoffs have been 13 reported by an increasing number of Hawaii businesses statewide, 14 from the agricultural sector to the medical services sector. 15 Hawaii's automobile dealers have cut fifteen per cent of their 16 workforce and that percentage could double in the future. 17 Financial uncertainty has caused decreased visitor arrivals and

- 1 employee hours. Furthermore, recent forecasts show that the
- 2 situation will worsen with a continued decline in jobs, personal
- 3 income, and visitor arrivals, and with rising inflation.
- 4 Difficult economic times and declining tax revenues have
- 5 resulted in budget cuts for all state services. State
- 6 departments have been asked to lower their budget proposals by
- 7 up to twenty per cent. The department of education faces a
- 8 possible \$70,000,000 shortfall for the next academic year and
- 9 funding has discontinued for science textbooks and materials,
- 10 programs for literacy training for learning-disabled children,
- 11 as well as for speech pathologists, occupational, and physical
- 12 therapists, and more than two hundred other positions.
- The department of health has projected a \$25,000,000
- 14 shortfall for mental health services and a \$5,400,000 shortfall
- 15 for developmental disabilities services in the current fiscal
- 16 year. Funding has been eliminated for the healthy start
- 17 program, totaling approximately \$22,000,000 for the biennium.
- 18 Additionally, the governor has discontinued funding for the
- 19 Hawaii children's health care program, which may leave an
- 20 estimated one thousand five hundred gap group children without
- 21 access to affordable health care.

- 1 The current and impending situation jeopardizes the safety
- 2 net of basic human services, health, and education needs for
- 3 Hawaii's residents and families. And while all of Hawaii's
- 4 residents will be affected by the situation, gap group families
- 5 and families closest to the poverty line will suffer the most.
- 6 The legislature finds that expenditures from the emergency
- 7 and budget reserve fund established by section 328L-3, Hawaii
- 8 Revised Statutes, are needed to meet the conditions of
- 9 emergency, economic downturn, and unforeseen reduction in
- 10 revenues that the State currently faces. Further, the
- 11 legislature finds that the appropriations in this Act are
- 12 consistent with the purposes of the emergency and budget reserve
- 13 fund.
- 14 The purpose of this Act is to appropriate moneys from the
- 15 emergency and budget reserve fund of the State of Hawaii to
- 16 maintain the levels of programs determined to be essential to
- 17 education, public health, and public welfare.
- 18 SECTION 2. There is appropriated out of the emergency and
- 19 budget reserve fund of the State of Hawaii the sum of \$463,340
- 20 or so much thereof as may be necessary for fiscal year 2010-2011
- 21 for respite services.

- 1 The sum appropriated shall be expended by the department of
- 2 health for the purposes of this Act.
- 3 SECTION 3. There is appropriated out of the emergency and
- 4 budget reserve fund of the State of Hawaii the sum of \$4,000,000
- 5 or so much thereof as may be necessary for fiscal year 2010-2011
- 6 to supplement the healthy start program.
- 7 The sum appropriated shall be expended by the department of
- 8 health for the purposes of this Act.
- 9 SECTION 4. There is appropriated out of the emergency and
- 10 budget reserve fund of the State of Hawaii the sum of \$470,000
- 11 or so much thereof as may be necessary for fiscal year 2010-2011
- 12 to provide funding for grants pursuant to chapter 42F, Hawaii
- 13 Revised Statutes, to be distributed as follows:
- 14 (1) Catholic Charities Hawaii \$200,000
- 15 (2) Kapahulu Center \$100,000
- 16 (3) Moiliili Community Center \$ 50,000
- 17 (4) Waikiki Community Center \$120,000
- 18 The sum appropriated shall be expended by the department of
- 19 health for the purposes of this Act.
- 20 SECTION 5. There is appropriated out of the emergency and
- 21 budget reserve fund of the State of Hawaii the sum of \$2,963,411

- 1 or so much thereof as may be necessary for fiscal year 2010-2011
- for the purposes of maintaining kupuna care services. 2
- 3 The sum appropriated shall be expended by the department of
- 4 health for the purposes of this Act.
- 5 SECTION 6. There is appropriated out of the emergency and
- 6 budget reserve fund of the State of Hawaii the sum of \$220,000
- 7 or so much thereof as may be necessary for fiscal year 2010-2011
- 8 for the Aging and Disability Resource Center.
- 9 The sum appropriated shall be expended by the department of
- 10 health for the purposes of this Act.
- 11 SECTION 7. There is appropriated out of the emergency and
- budget reserve fund of the State of Hawaii the sum of \$7,000,000 12
- 13 or so much thereof as may be necessary for fiscal year 2010-2011
- 14 for the developmental disabilities medicaid waiver program.
- 15 The sum appropriated shall be expended by the department of
- 16 health for the purposes of this Act.
- 17 SECTION 8. There is appropriated out of the emergency and
- 18 budget reserve fund of the State of Hawaii the sum of
- 19 \$13,000,000 or so much thereof as may be necessary for fiscal
- 20 year 2010-2011, for mental health services.
- The sum appropriated shall be expended by the department of 21
- 22 health for the purposes of this Act.





- 1 SECTION 9. There is appropriated out of the emergency and
- 2 budget reserve fund of the State of Hawaii the sum of \$500,000
- 3 or so much thereof as may be necessary for fiscal year 2010-
- 4 2011, for the partnerships in community living program.
- 5 The sum appropriated shall be expended by the department of
- 6 health for the purposes of this Act.
- 7 SECTION 10. There is appropriated out of the emergency and
- 8 budget reserve fund of the State of Hawaii the sum of \$3,500,000
- 9 or so much thereof as may be necessary for fiscal year 2010-2011
- 10 for direct health care to the uninsured, which may include
- 11 primary medical, dental, and behavioral health care.
- 12 The sum appropriated shall be expended by the department of
- 13 health for the purposes of this Act.
- 14 SECTION 11. There is appropriated out of the emergency and
- 15 budget reserve fund of the State of Hawaii, as a substance abuse
- 16 prevention and treatment block grant, the sum of \$2,400,000 or
- 17 so much thereof as may be necessary for fiscal year 2010-2011
- 18 for substance abuse treatment.
- 19 The sum appropriated shall be expended by the department of
- 20 health for the purposes of this Act.
- 21 SECTION 12. There is appropriated out of the emergency and
- 22 budget reserve fund of the State of Hawaii the sum of \$250,000



- 1 or so much thereof as may be necessary for fiscal year 2010-2011
- 2 for the healthy aging partnerships program.
- 3 The sum appropriated shall be expended by the department of
- 4 health for the purposes of this Act.
- 5 SECTION 13. There is appropriated out of the emergency and
- 6 budget reserve fund of the State of Hawaii the sum of \$332,000
- 7 or so much thereof as may be necessary for fiscal year 2010-2011
- 8 for the Waianae Coast Comprehensive Health Center to support
- 9 financial losses for its emergency room services.
- 10 The sum appropriated shall be expended by the department of
- 11 health for the purposes of this Act.
- 12 SECTION 14. There is appropriated out of the emergency and
- 13 budget reserve fund of the State of Hawaii as a grant pursuant
- 14 to chapter 42F, Hawaii Revised Statutes, the sum of \$550,000 or
- 15 so much thereof as may be necessary for fiscal year 2010-2011
- 16 for the Hawaii immigrant health initiative program.
- 17 The sum appropriated shall be expended by the department of
- 18 human services for the purposes of this Act.
- 19 SECTION 15. There is appropriated out of the emergency and
- 20 budget reserve fund of the State of Hawaii the sum of \$600,000
- 21 or so much thereof as may be necessary for fiscal year 2010-2011
- 22 for the Hawaii children's health care program.



- 1 The sum appropriated shall be expended by the department of
- 2 human services for the purposes of this Act.
- 3 SECTION 16. There is appropriated out of the emergency and
- 4 budget reserve fund of the State of Hawaii the sum of \$762,500
- 5 or so much thereof as may be necessary for fiscal year 2010-2011
- 6 for domestic violence shelters.
- 7 The sum appropriated shall be expended by the department of
- 8 human services for the purposes of this Act.
- 9 SECTION 17. There is appropriated out of the emergency and
- 10 budget reserve fund of the State of Hawaii the sum of \$233,280
- 11 for fiscal year 2010-2011 for the Hale Mahaolu Adult program for
- 12 personal care services.
- 13 The sum appropriated shall be expended by the department of
- 14 human services for the purposes of this Act.
- 15 SECTION 18. There is appropriated out of the emergency and
- 16 budget reserve fund of the State of Hawaii the sum of \$8,400,000
- or so much thereof as may be necessary for fiscal year 2010-2011
- 18 for disproportionate share hospital costs.
- 19 The sum appropriated shall be expended by the department of
- 20 human services for the purposes of this Act.
- 21 SECTION 19. There is appropriated out of the emergency and
- 22 budget reserve fund of the State of Hawaii the sum of \$7,000,000



- 1 or so much thereof as may be necessary for fiscal year 2010-2011
- 2 for medicaid provider reimbursements.
- 3 The sum appropriated shall be expended by the department of
- 4 human services for the purposes of this Act.
- 5 SECTION 20. There is appropriated out of the emergency and
- 6 budget reserve fund of the State of Hawaii the sum of \$300,000
- 7 or so much thereof as may be necessary for fiscal year 2010-2011
- 8 for outstationed eligibility worker services.
- 9 The sum appropriated shall be expended by the department of
- 10 human services for the purposes of this Act.
- 11 SECTION 21. There is appropriated out of the emergency and
- 12 budget reserve fund of the State of Hawaii the sum of \$40,525 or
- 13 so much thereof as may be necessary for fiscal year 2010-2011
- 14 for outreach services.
- 15 The sum appropriated shall be expended by the department of
- 16 human services for the purposes of this Act.
- 17 SECTION 22. There is appropriated out of the emergency and
- 18 budget reserve fund of the State of Hawaii the sum of \$164,000
- 19 or so much thereof as may be necessary for fiscal year 2010-2011
- 20 for outreach services to locate uninsured children.
- 21 The sum appropriated shall be expended by the department of
- 22 human services for the purposes of this Act.



- 1 SECTION 23. There is appropriated out of the emergency and
- 2 budget reserve fund of the State of Hawaii the sum of \$125,000
- 3 or so much thereof as may be necessary for fiscal year 2010-2011
- 4 for outreach services to locate uninsured adults.
- 5 The sum appropriated shall be expended by the department of
- 6 human services for the purposes of this Act.
- 7 SECTION 24. There is appropriated out of the emergency and
- 8 budget reserve fund of the State of Hawaii the sum of \$420,595
- 9 or so much thereof as may be necessary for fiscal year 2010-2011
- 10 for housing placement services.
- 11 The sum appropriated shall be expended by the department of
- 12 human services for the purposes of this Act.
- 13 SECTION 25. There is appropriated out of the emergency and
- 14 budget reserve fund of the State of Hawaii the sum of \$500,000
- or so much thereof as may be necessary for fiscal year 2010-2011
- 16 for the shelter plus care program.
- 17 The sum appropriated shall be expended by the department of
- 18 human services for the purposes of this Act.
- 19 SECTION 26. There is appropriated out of the emergency and
- 20 budget reserve fund of the State of Hawaii the sum of \$500,000
- 21 or so much thereof as may be necessary for fiscal year 2010-2011
- 22 for the Oahu safe house program.



- 1 The sum appropriated shall be expended by the department of
- 2 human services for the purposes of this Act.
- 3 SECTION 27. There is appropriated out of the emergency and
- 4 budget reserve fund of the State of Hawaii the sum of
- 5 \$ or so much thereof as may be necessary for fiscal
- 6 year 2010-2011 for adult dental services.
- 7 The sum appropriated shall be expended by the department of
- 8 human services for the purposes of this Act.
- 9 SECTION 28. There is appropriated out of the emergency and
- 10 budget reserve fund of the State of Hawaii the sum of
- 11 \$ or so much thereof as may be necessary for fiscal
- 12 year 2010-2011 for medicaid.
- 13 The sum appropriated shall be expended by the department of
- 14 human services for the purposes of this Act.
- 15 SECTION 29. There is appropriated out of the emergency and
- 16 budget reserve fund of the State of Hawaii the sum of
- 17 \$ or so much thereof as may be necessary for fiscal
- 18 year 2010-2011 for child care.
- 19 The sum appropriated shall be expended by the department of
- 20 human services for the purposes of this Act.
- 21 SECTION 30. There is appropriated out of the emergency and
- 22 budget reserve fund of the State of Hawaii the sum of



- 1 \$ or so much thereof as may be necessary for fiscal
- 2 year 2010-2011 for general assistance.
- 3 The sum appropriated shall be expended by the department of
- 4 human services for the purposes of this Act.
- 5 SECTION 31. There is appropriated out of the emergency and
- 6 budget reserve fund of the State of Hawaii the sum of \$2,700,000
- 7 or so much thereof as may be necessary for fiscal year 2010-2011
- 8 for domestic violence services.
- 9 The sum appropriated shall be expended by the judiciary for
- 10 the purposes of this Act.
- 11 SECTION 32. There is appropriated out of the emergency and
- 12 budget reserve fund of the State of Hawaii the sum of \$400,000
- 13 or so much thereof as may be necessary for fiscal year 2010-2011
- 14 for Volunteer Legal Services Hawaii to provide pro bono legal
- 15 services for indigent persons.
- 16 The sum appropriated shall be expended by the judiciary for
- 17 the purposes of this Act.
- 18 SECTION 33. There is appropriated out of the emergency and
- 19 budget reserve fund of the State of Hawaii the sum of \$720,000
- 20 or so much thereof as may be necessary for fiscal year 2010-2011
- 21 for the Legal Aid Society of Hawaii to provide general civil
- 22 legal services.
