A BILL FOR AN ACT

RELATING TO HISTORIC PLACES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that archaeological sites 2 or features such as heiau, agricultural and irrigation lo'i, and 3 footpaths that are built into the earth by the Hawaiian people 4 have a cultural significance to the State. Once identified, 5 surveyed, and listed on the Hawaii or national register of 6 historic places, these sites or features should be protected by 7 state law. 8 The purpose of this Act is to protect archaeological sites 9 or features, such as those built by early Hawaiians. 10 SECTION 2. Chapter 6E, Hawaii Revised Statutes, is amended 11 by adding a new section to be appropriately designated and to 12 read as follows: 13 Destruction of archaeological site or "§6E-14 archaeological feature. Any inadvertent destruction of an 15 archaeological site or archaeological feature shall be examined 16 by an archaeologist of the historic preservation division and a 17 person with knowledge of Hawaiian culture, such as an aha moku 18 or the office of Hawaiian affairs. 1	division shall submit a report to the board of land natural
2	resources on the historical significance and current state of
3	the site. When determining the historical significance of an
4	archaeological site or archaeological feature, oral history
5	shall prevail unless scientific evidence is demonstrated."
6	SECTION 3. Section 6E-2, Hawaii Revised Statutes, is
7	amended by adding a new definition to be appropriately inserted
8	and to read as follows:
9	" "Archaeological site" or "archaeological feature" includes
10	but is not limited to any structure built into the earth by the
11	early Hawaiians including heiau, agricultural and irrigation
12	lo'i, and footpaths."
13	SECTION 4. Section 6E-11, Hawaii Revised Statutes, is
14	amended by amending subsection (a) to read as follows:
15	"(a) It shall be a civil and administrative violation for
16	any person to take, appropriate, excavate, injure, destroy, or
17	alter any historic property or aviation artifact located upon
18	[the]:
19	(1) The private lands of any owner thereof without the
20	owner's written permission being first obtained[. It
21	shall-be a civil-and-administrative-violation for any

1	destroy, or alter any historic property or aviation
2	artifact located upon lands]; and
3	(2) Lands owned or controlled by the State or any of its
4	political subdivisions, except as permitted by the
5	department, or to knowingly violate the conditions set
6	forth in an approved mitigation plan that includes
7	monitoring and preservation $plans[-]$;
8	provided that it shall be a civil and administrative violation
9	for a person, who has actual knowledge of the historic status of
10	the archaeological site or archaeological feature, to wilfully
11	alter or destroy an archaeological site or archaeological
12	feature listed on the Hawaii or national register of historic
13	places found on privately owned land or lands owned or
14	controlled by the State or any of its political subdivisions."
15	SECTION 5. Statutory material to be repealed is bracketed
16	and stricken. New statutory material is underscored.
17	SECTION 6. This Act shall take effect on July 1, 2020.

Report Title:

Historic Preservation; Register of Historic Places

Description:

Defines archaeological site or archaeological feature. Requires the historic preservation division of DLNR to report on the state and historical significance of an archaeological site if inadvertently destroyed. Provides for penalties for wilful alteration or destruction of an archaeological site or archaeological feature on the Hawaii or national register of historic places. (HB2480 HD1)
