## A BILL FOR AN ACT

RELATING TO PUBLIC HOUSING.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that neglect and
- 2 disrepair continue to plague state public housing projects, and
- 3 believes that, especially during the current economic crisis,
- 4 housing residents must take a more active role in reducing
- 5 maintenance costs by properly caring for their housing units.
- 6 The purpose of this Act is to encourage housing residents
- 7 to play a more active role in maintaining their housing project
- 8 by holding housing residents directly responsible for damages
- 9 caused to a housing unit or common areas by the resident.
- 10 SECTION 2. Chapter 356D, Hawaii Revised Statutes, is
- 11 amended by, adding a new section to be appropriately designated
- 12 and to read as follows:
- 13 "\$356D- Common area expenses; reimbursement for
- 14 damages. (a) If any common area expense is caused by the
- 15 misconduct of any unit resident, the authority may assess the
- 16 cost of that expense exclusively against that unit resident.

1 The authority shall seek reimbursement from a unit 2 resident for the full cost of any damages to a unit caused by 3 the unit resident." SECTION 3. Section 356D-42, Hawaii Revised Statutes, is 4 5 amended to read as follows: 6 "[+] §356D-42[+] Housing; tenant selection. Subject to the 7 following limitations and preferences, the authority shall 8 select tenants [upon the basis of those in greatest need] for the particular housing. The authority may limit the tenants of 9 **10** any state low-income housing project to classes of persons when 11 required by federal law or regulation as a term or condition of 12 obtaining assistance from the federal government[... Within the 13 priorities established by the authority recognizing need], 14 including veterans with a permanent disability of ten per cent 15 or more as certified by the United States Department of Veterans **16** Affairs, the dependent parents of the veteran, and the deceased **17** veteran's widow, who shall be given first preference." 18 SECTION 4. Statutory material to be repealed is bracketed

and stricken. New statutory material is underscored.

SECTION 5. This Act shall take effect upon its approval.
