RELATING TO THE INTERDEPARTMENTAL COUNCIL ON EARLY CHILDHOOD EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The Legislature finds that the American
- 2 Recovery and Reinvestment Act of 2009, Pub. L. No. 111-5, made
- 3 \$100,000,000 in federal funding available to states to improve
- 4 coordination and collaboration among early childhood education
- 5 and care programs and services. The federal government will
- 6 award these funds to eligible states that develop and implement
- 7 a plan to improve early childhood education.
- 8 Act 77, Session Laws of Hawaii 1997, was enacted in
- 9 response to the demand for an agency that focused exclusively on
- 10 the needs of young children. Act 77 established the nonprofit
- 11 Good Beginnings Alliance, and its public counterpart, the
- 12 interdepartmental council. The purpose of the interdepartmental
- 13 council is to improve coordination of state policy issues
- 14 affecting young children and their families
- 15 The purpose of this Act is to advantageously position the
- 16 State to apply for federal stimulus money for early childhood

- 3 SECTION 2. Act 77, Session Laws of Hawaii 1997, as amended
- 4 by section 2(2) of Act 60, Session Laws of Hawaii 2000, is
- 5 amended by amending section -4 of the chapter established in
- 6 section 2 of the Act to read as follows:
- 7 "S -4 Interdepartmental council. There shall be a

PURPOSE:

Extend the sunset date of the

Interdepartmental Council on Early Childhood Education from June 30, 2010, to June 30, 2013, and adds four new members to the

Council.

MEANS:

Amend section -4 of section 2 and section 3 of Act 77, Session Laws of Hawaii 1997, as amended by Act 60, Session Laws of Hawaii 2000

JUSTIFICATION:

The American Recovery and Reinvestment Act of 2009 has made federal funding available to states in order to improve early childhood education and care programs and services.

In order to access the stimulus funds, the federal government requires states to designate an Advisory Council on Early Childhood Education and Care to assist with the state-level coordination for early childhood programs.

To ensure Hawaii's eligibility for federal funding, this bill extends the life of the Interdepartmental Council on Early Childhood Education (Council), established pursuant to Act 77, Session Laws of Hawaii 1997. The Council will serve as the State's Advisory Council and assist with the state-level coordinator among the various sectors and settings of early childhood education in the State. The Council currently serves as the public sector counterpart to the nonprofit Good Beginnings Alliance.

Additionally, this bill increases the Council's membership by adding four new members to represent institutes of higher education located in the State, local providers of early childhood education and development services, Head Start agencies located in the State, and Head Start Collaboration.

Impact on the public: Increased federal funding will improve the State's delivery and coordination of early childhood education programs and services to Hawaii's children and their families.

Impact on the department and other agencies: Requires current representatives serving on the Interdepartmental Council on Early Childhood Education to extend their duties for an additional three years.
